INTERNATIONAL FURNITURE PARK

• Chief Minister M.K. Stalin will lay foundation stone on January 11 for the country's first ever International Furniture Park, which is coming up on the outskirts of this town on 1,150 acres on an outlay of ₹1,000 crore.

About

- Thoothukudi, the country's third largest timber importer, imports logs from Mayanmar, Australia, New Zealand and the African countries via VOC Port and sends the imported timber by road to the sawmills in various destinations.
- The proposed industrial complex will house a maximum of 100 furniture manufacturing units.

ESTABLISHING OF NEW MEDICAL COLLEGES ATTACHED WITH EXISTING DISTRICT/REFERRAL HOSPITAL

 Prime Minister Narendra Modi will inaugurate 11 New Government Medical Colleges across Tamil Nadu on 12th January, 2022.

About

 The new medical colleges, with cumulative capacity of 1450 seats, are being established under the Centrally Sponsored scheme of 'Establishing of New Medical Colleges attached with existing district/referral hospital'. Under the scheme, medical colleges are established in districts, which do not have either a government or private medical college.

CENTRAL INSTITUTE OF CLASSICAL TAMIL (CICT)

 Prime Minister Shri Narendra Modi will inaugurate the new campus of Central Institute of Classical Tamil in Chennai

- The establishment of a new campus of Central Institute of Classical Tamil (CICT) in Chennai is in line with the Prime Minister's vision to protect and preserve Indian heritage and promote classical languages.
- The new campus is fully funded by the Union Government and is built at a cost of Rs 24 Crore.
- CICT, which was operating from a rented building so far, will now operate from a new 3 storey campus.
- An autonomous organization under the Union Ministry of Education, CICT is contributing to the promotion of classical Tamil by doing research activities so as to establish the ancientness and uniqueness of Tamil language.
- To promote classical Tamil and support its students, the Institute indulges in academic activities like holding seminars and training programmes, granting fellowship etc. It also aims to translate and publish 'Thirukkural' in various Indian as well as 100 foreign languages.

VINISHA UMASHANKAR

 Ms. Vinisha Umashankar, a student innovator turned environmentalist from Tiruvannamalai district of Tamil Nadu, has been selected as a "changemaker" and Batonbearer for the ongoing 16th official Queen's Baton Relay (12-15 January 2022) in India.

About

Mobile ironing cart

- Vinisha Umashankar received the Dr. APJ Abdul Kalam IGNITE Awards instituted by National Innovation Foundation (NIF)

 India, an autonomous body of the Department of Science and Technology for her mobile ironing cart.
- The cart uses solar panels to power a steam iron box and turned out to be an inspiration for the world after her speech at the 26th Conference of the Parties to the UN Framework Convention on Climate Change in 2021 at Glasgow, Scotland.
- A key benefit of Vinisha's solar ironing cart is that it eliminates the need for coal for ironing bringing about a welcome shift towards clean energy. End-users can move around and offer services at doorstep for increasing their daily earning.
- The ironing cart can also be fitted with a coin-operated GSM PCO, USB charging points, and mobile recharging, which can fetch extra income.
- India is committed towards solving the global climate change problem through Science, Technology, and Innovation based solutions.
- It's the next generation of innovators like Vinisha who provide the nation a strong hope that "Tomorrow can be better

than today" by virtue of their scientific thinking, societal focus, and institutional support mechanism like the one offered by NIF in India, which could be replicated in other parts of the world.

NEW MOBILE-BASED LEAVE APP FOR CHENNAI POLICE PERSONNEL ROLLED OUT

- A new mobile-based app has been launched for police personnel in Chennai to apply for leave and to get it sanctioned immediately, without any hassle.
- The new mobile app, called CLAPP (Complete Leave APP) has been designed to eradicate delays, summary rejections or favoritism by the sanctioning authority and is aimed at ensuring more transparency in the leave process.
- The sanctioning authority must process and sanction the leave within three hours.
 If there is delay for more than three hours, it will be escalated to the superior officer above the sanctioning officer

TIRUVALLUVAR AND KAMARAJAR AWARDS

- The state government of Tamil Nadu announced the recipients of Tiruvalluvar and Kamarajar awards.
- Chief Minister MK Stalin issued orders to confer Ayyan Thiruvalluvar Award for the year 2022 on former president of Bengaluru Tamil Sangam, M Meenakshi Sundaram who was instrumental in erecting the statue of Tiruvalluvar in Bengaluru.
- A statement said that Perunthalaivar Kamarajar award for the year 2021 would be conferred on veteran politician Kumari Ananthan, who has also served as MP and MLA.

PADMA AWARDS FROM TAMIL NADU

- Seven achievers from various fields from Tamil Nadu and one from Puducherry have been chosen for the Padma Shri awards
- Sirpi Balasubramaniam (Literature and Education), S Ballesh Bhajantri (Art), S Damodaran (Social Work), Sowcar Janaki (Art), R Muthukanammal (Art), AKC Natarajan (Art), Dr Veerasamy Seshiah (Medicine) Thavil Kongampattu AV Murugaiyyan (Art)

Sirpi Balasubramaniam

Distinguished Tamil Poet, scholar and a two-time Sakitya Akademy winner. Balasubramanaiam had served as the head of the Department of Tamil at Bharatiar University in Coimbatore. He has won several awards including the Bharathidasan award, Government of Tamil Nadu award among many others. Some of his finest works include Siritha Muthukkal, Sooriya Nizhal, Oru Gramathu Nadhi, etc. His poems have been translated into English, Kannada, Hindi, Malayalam, etc.

• Muthukannamal is among the last Devadasi Sathir dancer from Viralimalai, Trichy. Sathir, is an ancient dance form. She served the deity at the Murugan temple in Viralimalai. In 2018, she was honoured with DakshinaChitra Virudhu, an annual award presented by the Friends of Dakshinachitra to honour the folk performing artists

AKC Natarajan

 Hailed as the Clarinet Everest, Natarajan is a recipient of the Madras Music Academy's Sangeetha Kalanidhi in 2008. He even received the Sangeet Natak Akademi award in 1994. Considered a legendary icon, he had performed in various leading Sabhas in Chennai and other cities and been part of several concerts.





DEFENCE RESEARCH AND DEVELOPMENT ORGANISATION

• The Defence Research and Development Organisation (DRDO) has observed the 64th Foundation Day of its establishment on January 01, 2022.

About

- DRDO was established in 1958 with just 10 laboratories to enhance the research work in the Defence secto
- DRDO is working in multiple cutting edge military technology areas, which include aeronautics, armaments, combat vehicles, electronics, instrumentation, engineering systems, missiles, materials, naval systems, advanced computing, simulation, cyber, life sciences and other technologies for defence.
- DRDO Headquarters: New Delhi.
- DRDO Established: 1958

DRAFT NATIONAL AIR SPORTS POLICY (NASP 2022)

- Ministry of Civil Aviation has released draft National Air Sports Policy (NASP) for public feedback.
- The key features of the Draft National Air Sports Policy are:
- NASP 2022 covers sports like aerobatics, aeromodelling, amateur-built and experimental aircraft, ballooning, drones, gliding, hang gliding and paragliding; microlighting and paramotoring; skydiving and vintage aircraft.

- The vision is to make India one of the top air sports nations by 2030. The mission is to provide a safe, affordable, accessible, enjoyable and sustainable air sports ecosystem in India.
- NASP 2022 seeks to leverage India's huge potential for air sports given its large geographical expanse, diverse topography and fair weather conditions.
- An Air Sports Federation of India (ASFI) will be established as the apex governing body. Associations for each air sport will handle day to day activities e.g. Paragliding Association of India or Skydiving Association of India etc.
- The air sports associations shall be accountable to ASFI with respect to the regulatory oversight and for providing safe, affordable, accessible, enjoyable and sustainable conduct of their respective air sport.
- ASFI shall represent India at FAI and other global platforms related to air sports. Greater participation and success of Indian sportspersons in global air sports events will be facilitated.
- Domestic design, development and manufacturing of air sports equipment will be promoted in line with the Atmanirbhar Bharat Abhiyan.
- The Fédération Aéronautique Internationale (FAI), headquartered in Lausanne, Switzerland is the world governing body for air sports. All competitions in India will be conducted as per the guidelines laid down by FAI.

 Air sports by their very nature involve a higher level of risk than flying a regular aircraft. NASP 2022 places strong focus on ensuring international best practices in safety.

SMALL-VALUE DIGITAL PAYMENTS IN OFFLINE MODE

• The Reserve Bank of India (RBI) has come out with the framework for facilitating small-value digital payments in offline mode, a move that would promote digital payments in semi-urban and rural areas.

About

- The framework incorporates feedback received from the pilot experiments on offline transactions conducted in different parts of the country between September 2020 and June 2021.
- An offline digital payment does not require Internet or telecom connectivity.
- Under this new framework, such payments can be carried out face-to-face (proximity mode) using any channel or instrument like cards, wallets and mobile devices.
- Such transactions would not require an Additional Factor of Authentication.
 Since the transactions are offline, alerts (by way of SMS and / or e-mail) will be received by the customer after a time lag.
- There is a limit of ₹200 per transaction and an overall limit of ₹2,000 until the balance in the account is replenished. The RBI said the framework took effect 'immediately'.

KALPANA CHAWLA CENTRE FOR RESEARCH IN SPACE SCIENCE & TECHNOLOGY (KCCRSST)

 Raksha Mantri Rajnath Singh inaugurated Kalpana Chawla Centre for Research in Space Science & Technology (KCCRSST) at Chandigarh University on January 03, 2022.

- It is established with the objective of training students in space science, satellite development and meet future challenges in space research.
- KCCRSST would be the Ground Control Station for the Chandigarh University's Student Satellite (CUSat), an in-house developed nano-satellite being designed by the students of the university and a Geo-Spatial Centre for research, besides other projects.
- The CUSat will be among the 75 studentbuilt satellites to be launched into space on the eve of the 75thIndependence Day in 2022.
- The Chandigarh University has joined the list of 13 institutes like Indian Institute of Technology (IIT) Kanpur, IIT Bombay and became the first university in North India to design and develop its own satellite.
- With the launch of CUSat, Punjab will become the first border state in India to have its own satellite in space.
- The launch of the university's nanosatellite CUSat will prove to be an important step for the country, as it will collect data related to border intrusion detection, agriculture, weather forecasting, natural disaster forecasting, which will be helpful in research and study of various problems in these areas.

NAI TALIM

 Addressing the Silver Jubilee Celebrations of Mahatma Gandhi International Hindi University, Wardha, the Vice President of India, Venkaiah Naidu recalled that the "Nai Talim" proposed by Mahatma Gandhi in Wardha in 1937 laid emphasis on making mother tongue as the medium of instruction in addition to free compulsory education and skill training to the students.

About

- Nai Talim is a concept of basic education system by Mahatma Gandhi.
- Basic Education is a principle which states that knowledge and work are not separate. Mahatma Gandhi promoted an educational curriculum with the same name based on this pedagogical principle.
- The three pillars of Gandhi's pedagogy were its focus on the lifelong character of education, its social character and its form as a holistic process.
- For Gandhi, education is 'the moral development of the person', a process that is by definition 'lifelong'.

About

 The Bureau of Indian Standards (BIS) is the National Standards Body of India under Department of Consumer affairs, Ministry of Consumer Affairs, Food

- & Public Distribution, Government of India.
- It is established by the Bureau of Indian Standards Act, 2016 which came into effect on 12 October 2017.
- The Minister in charge of the Ministry or Department having administrative control of the BIS is the ex-officio President of the BIS.
- A new Bureau of Indian standards (BIS)
 Act 2016 which was notified on 22
 March 2016, has been brought into force
 with effect from 12 October 2017. The
 Act establishes the Bureau of Indian
 Standards (BIS) as the National Standards
 Body of India.

AROMA MISSION

- The Aroma Mission launched by the Union Ministry of Science & Technology through the Council of Scientific & Industrial Research (CSIR), has led to the well-known "Purple Revolution" in India.
- The CSIR had, to begin with introduced high-value essential oil bearing lavender crop through its Jammu based laboratory, Indian Institute of Integrative Medicines (IIIM) for cultivation in districts Doda, Kishtwar, Rajouri and later also in the other districts including Ramban, Pulwama, etc.
- In addition to IIIM, CSIR-IHBT, CSIR-CIMAP, CSIR-NBRI and CSIR-NEIST are also now participating in the Aroma Mission

GOAT HEAD YOGINI

 Culture Minister G Kishan Reddy announced that a 10th century stone idol of Goat Head Yogini that had been illegally removed from a temple in Lokhari, Banda, Uttar Pradesh is being returned to India.

(ISI) in 1947.



About

- Earlier, the High Commission of India in London announced the recovery and repatriation of the 10th century stone idol that had been illegally removed.
- The sculpture is of a goat headed Yogini that originally belonged to a group of stone deities in sandstone and installed in Lokhari temple.
- The sculpture had briefly surfaced in the art market in London in 1988.
- In October last year, High Commission of India received information about the finding of a goat-headed Yogini Sculpture that had matched the description of the Lokhari set, in the garden of a private residence near London.

INDIA'S COVID-19 VACCINATION

• India marks the first anniversary of the nationwide vaccination drive against Covid-19 on January 16, 2022

About

- It was on this day last year, Prime Minister Narendra Modi had launched the world's largest vaccination drive to combat the pandemic.
- Vaccination began with health workers on 16th January last year.
- Then it opened for frontline workers on 2nd February last year, followed by the 60-plus age group and those above 45-years and comorbid from 1st March

- and for all above 18 years from 1st May in 2021.
- The drive for administering precautionary dose to the healthcare workers, frontline workers and sixty plus individuals commenced on 10th this month.
- Vaccination of children in the age-group of 15-18 years was started from 3rd of this month.
- Meanwhile, India's Covid vaccination coverage has crossed 156 crore 63 lakh mark.

COMMEMORATIVE POSTAL STAMP



- GoI launches stamp to mark 1 year of Covid vaccination
- The government of India has released a commemorative postal stamp on the Covid-19 vaccination on Sunday to mark the first anniversary of the country's national immunization programme against the virus.
- The commemorative stamp design features a healthcare worker inoculating a senior citizen with COVID-19 vaccine, along with an image of 'COVAXIN' vial.
- This stamp signifies the remarkable work done by our frontline healthcare workers and scientific community across the country in protecting the people against the COVID pandemic.

NEAT 3.0

 Union Education Minister and Skill Development Minister Dharmendra Pradhan launched NEAT 3.0, a single platform to provide the best-developed ed-tech solutions and courses to students of the country.

About

- Pradhan said NEAT will be a gamechanger in bridging the digital divide, especially among the economically disadvantaged students and also in fulfilling the knowledge-based requirement of India and the world.
- National Educational Alliance for Technology (NEAT) is an initiative to provide the use of best-developed technological solutions in the education sector to enhance the employability of the youth on a single platform for learners' convenience.
- These solutions use artificial intelligence for a personalised and customised learning experience for better learning outcomes and skill development in the niche areas.
- The minister informed that 58 global and Indian start-up ed-tech companies are onboard NEAT and are offering 100 courses and e-resources for bettering learning outcomes, developing employable skills and overcoming learning loss.
- The minister expressed his happiness that, more than 12 lakh socially and economically disadvantaged students have received free ed-tech course coupons worth over Rs 253 crore under NEAT 3.0.

CSIR-NATIONAL PHYSICAL LABORATORY (NPL)

• Union Minister Dr Jitendra Singh launches

the Platinum Jubilee Celebrations of CSIR-National Physical Laboratory (NPL) New Delhi, which is one of the earliest CSIR laboratories that was set up around the time of independence and its 75th year coincides with the 75th year of India's independence.

About

- The CSIR- National Physical Laboratory of India, situated in New Delhi, is the measurement standards laboratory of India.
- It maintains standards of SI units in India and calibrates the national standards of weights and measures.
- It was one of the earliest national laboratories set up under the Council of Scientific & Industrial Research (CSIR). Jawaharlal Nehru laid the foundation stone of NPL on 4 January 1947.
- K. S. Krishnan was the first Director of the laboratory.



 Bharatiya Nirdeshak Dravya (BND) or Indian reference materials are reference materials developed by NPL which derive their traceability from National Standards.

LED PHOTOMETRY LABORATORY

• The Minister also dedicated the nation 'LED Photometry Laboratory' at CSIR-

- National Physical Laboratory, New Delhi to fulfill Prime Minister Narendra Modi's vision to develop energy-efficient illumination technology.
- This national level facility would contribute to making India 'Atma-Nirbhar' in the apex level calibration and testing of LED lighting products.
- These will not only save the foreign exchange spent on availing testing and calibration services from abroad but also significantly reduce turn-around time.
- Difference between LCD and LED
- LCD stands for liquid crystal display.
- LED stands for light-emitting ddiodes
- All LCDs are not a subset of LED TV.All LEDs are a subset of LCD TV.
- LCDs primarily use fluorescent lights. LEDs use light-emitting diodes.
- Fluorescent lights used are usually placed behind the screen. Light-emitting diodes are usually placed behind the screen or around the edges.
- LCDs are usually thicker and lack energy efficiency compared to LEDs.LEDs are much thinner and are much more energyefficient.

INDIRA GANDHI RASHTRIYA URAN AKADEMI (IGRUA)

 Indira Gandhi Rashtriya Uran Akademi (IGRUA)sets a new record of 19000 flying hours in 2021.

About

 During the year 2021, IGRUA piled up 19000 hours of flying as against an average yearly flying output of 15000 per year during the previous five years while it was 11641 hours in 2020.

- IGRUA achieved this milestone of 19000 hours despite continued effect of pandemic and inclement weather conditions due to Tauktae Cyclone in 2021.
- Indira Gandhi Rashtriya Uran Akademi(IGRUA) was established by the Government of India in the year 1986 at Fursatganj Airfield, presently in the district of Amethi in Uttar Pradesh.
- IGRUA is an Autonomous Body established under the Societies Registration Act 1860 and is administered by a Governing Council under the Exofficio Chairmanship of Secretary, Ministry of Civil Aviation.

25TH NATIONAL YOUTH FESTIVAL

• Union Minister of Youth Affairs and Sports unveiled the Logo and Mascot of the 25th National Youth Festival to be held in Puducherry from 12th -16th January 2022

- Shri Anurag Thakur also unveiled the tag-line of the National Youth Festival, Shaksham Yuva Shashakth Yuva meaning Capable Youth- Forceful Youth, Able Youth- Strong Youth.
- National Youth Festival is organized by the Government of India every year in collaboration with one of the States from January 12th to 16th to commemorate the birth anniversary of Swami Vivekananda i.e. 12th January.
- The basic objective of the NYF is to bring the youth of the country together in an attempt to showcase their talents in various activities to cover almost all socio-cultural aspects of life, providing an opportunity to amateur young artists to express themselves.

PM CHOSE PUDUCHERRY AS HOST OF NATIONAL YOUTH FESTIVAL

 Puducherry has been handpicked by Prime Minister Narendra Modi to host the 25th National Youth Festival. The 25th National Youth Festival is going to be held in Puducherry from 12th to 16th January 2022.

History

 National Youth Festival started in 1995 as a major activity under the programme held by National Integration Camp (NIC).

EXPENDITURE LIMIT FOR CANDIDATES IN PARLIAMENTARY AND ASSEMBLY POLLS

 The Election Commission has enhanced the existing election expenditure limit for candidates in Parliamentary and Assembly constituencies.

About

- These limits will be applicable in all upcoming elections.
- The ceiling on parliamentary poll expenditure has been raised from 70 lakh to 95 lakh rupees in bigger states and 54 lakh to 75 lakhs in smaller states.
- The bigger states include Maharashtra, Madhya Pradesh, Uttar Pradesh, West Bengal and Karnataka, and the smaller states include Goa, Sikkim, Arunachal Pradesh and UTs.
- The ceiling on poll expenditure in UT of Jammu and Kashmir has been raised to 95 lakhs.
- For Assembly constituencies, expenditure limits have been enhanced from 28 lakh rupees 40 lakh rupees in bigger states and from 20 lakhs to 28 lakhs in smaller

states.

 Last major revision in the election expenditure limit was carried out in 2014, which was further increased by 10 percent in 2020. EC had formed a Committee to study the cost factors and other related issues, and make suitable recommendations.

INTRA-STATE TRANSMISSION SYSTEM - GREEN ENERGY CORRIDOR PHASE-II

• The Cabinet Committee on Economic Affairs, the CCEA has approved the Intra-State Transmission System - Green Energy Corridor Phase-II.

- The scheme will add approximately 10,750 circuit kilometres of transmission lines and around 27, 500 Mega Volt-Amperes transformation capacity of substations.
- The scheme will facilitate grid integration and power evacuation of approximately 20 GW of Renewable Energy power projects in seven states.
- These states are Gujarat, Himachal Pradesh, Karnataka, Kerala, Rajasthan, Tamil Nadu and Uttar Pradesh.
- The scheme is targeted to be set up with a total estimated cost of over 12 thousand 31 crore rupees and Central Financial Assistance at 33 percent of the project cost, that amounts to over 3970 crore rupees.
- The transmission systems will be created over a period of five years from the Financial Year 2021-22 to 2025-26. The scheme will help in achieving the target of 450 GW installed Renewable Energy capacity by 2030.

24th CONFERENCE ON E-GOVERNANCE 2020-21

 Union Minister Dr Jitendra Singh will inaugurate the 24th Conference on e-Governance 2020-21 in Hyderabad

About

- The two-day conference themed 'India's Techade: Digital Governance in a Post Pandemic World' will be organized by the Department of Administrative Reforms and Public Grievances and Ministry of Electronics and Information Technology, in association with the Government of Telangana.
- During the event, National Awards for e-Governance 2021 will be presented under 6 categories to 26 e-Governance initiatives at Central, State and District levels and also to Academic and Research Institutions and Public Sector Undertakings.
- This includes 12 Gold, 13 Silver and 1 Jury Award.
- Delegates from 28 States and 9 Union Territories along with academia, research institutions, IT Industry would be participating in the conference through Virtual Mode.

STC (SCHEDULED TRIBE COMPONENT) PROJECT AT ATTAGATTI IN ANAMALAI TIGER RESERVE (ATR)

 ICAR – Sugarcane Breeding Institute (ICAR-SBI), Coimbatore in collaboration with Anamalai Tiger Reserve, conducted a campaign on "Knowledge empowerment of tribals' and launched its STC (Scheduled Tribe Component) project at Attagatti in Anamalai Tiger Reserve (ATR)

About

- Unlike other tiger reserves, the Anamalai Tiger Reserve has diverse groups of indigenous people, he mentioned.
- The 'Malasar' tribes are of great help to the Forest Department in training the elephants with their profound knowledge and skill on handling Asian elephants, the Deputy Director said that saving tribals is akin to saving forests.
- This is the first time this project is being implemented in ATR.
- The interventions by the Institute for implementing STC, was finalized based on a systematic need assessment by conduct of Focus groups among two tribes viz., 'Malasar' and 'Malai malasar' tribes belonging to the tribal settlements of Nagaroothu -1, Nagaroothu 2, Old Sarkarpathy, Chinnarpathy, Koomaatti and Paalakinaru.
- Since over 47 lakhs of Indian tribal children suffer from chronic nutrition deprivation, the tribal community in these settlements, will be educated on setting up and maintaining a nutrition garden and kitchen garden seed kits will be distributed during this campaign on 'knowledge empowerment of tribals'.

INDIA'S FIRST OPEN ROCK MUSEUM

 Union Minister of Science & Technology inaugurated India's first unique "Rock" Museum and later addressed the Hyderabad Scientists at the CSIR-National Geophysical Research Institute (NGRI).

About

• The Open Rock Museum, set up with the aim to educate and enlighten the masses

about several lesser known facts, displays around 35 different types of rocks from different parts of India with ages ranging from 3.3 Billion years to around 55 Million years of the Earth's history.

- These rocks also represent the deepest part of the earth up to 175 kms of distance from the surface of the earth.
- "Big Earth data" occupies the strategic high ground in the era of knowledge economies and India is fully exploiting this new frontier contributing to the advancement of Earth science.

INDIA'S FIRST MULTI-DIMENSIONAL ADVENTURE SPORTS EXPEDITION

 Minister of defence flagged-in India's first multi-dimensional adventure sports expedition conducted by National Institute of Mountaineering and Allied Sports (NIMAS) in France

About

- The expedition was conducted in November 2021 and the team was led by Director NIMAS Colonel Sarfaraz Singh, comprising 12 people - eight Army personnel and four youths of Arunachal Pradesh.
- The expedition team carried out over 250 kilometres of winter trekking in the Alps Mountain Ranges, which included Tour De Mont Blanc trek covering the French, Swiss and Italian Alps.

Mont Blanc

- Mont Blanc (meaning "white mountain") is the highest mountain in the Alps and the European Union, rising 4,807.81 m above sea level.
- It is the second-most prominent mountain in Europe, after Mount Elbrus.
- The mountain stands between the regions

of Aosta Valley, Italy, and Savoie and Haute-Savoie, France.

MOBILE HONEY PROCESSING VAN

• Chairman KVIC Shri Vinai Kumar Saxena launched the country's first Mobile Honey Processing Van at Village Sirora in Ghaziabad, UP.

About

- The Mobile Van has been designed inhouse by KVIC at its Multi-disciplinary
 Training Centre, Panjokehra, at a cost of
 Rs 15 lakh.
- This mobile honey processing unit can process up to 300 KG of honey in 8 hours.
- The van is also equipped with a testing laboratory that would instantly examine the quality of honey.
- The Mobile Honey Processing Van comes as a major development under KVIC's Honey Mission which aims at training beekeepers, distributing Bee Boxes to farmers and helping rural, educated as well as unemployed youth to earn extra income through beekeeping activities.
- In line with the Prime Minister's dream of "Sweet Kranti" (Sweet Revolution) through honey production, the KVIC has come up with this unique innovation to enable beekeepers and farmers to get fair prices for their honey produce.

3rd NATIONAL WATER AWARDS

About

- The first National Water Award was launched by the Jal Shakti Ministry in 2018.
- National Water Awards have provided a good opportunity to start-ups as well as leading organizations to engage and deliberate with senior policymakers on how to adopt the best water resources management practices in India.
- The Department of Water Resources, River Development and Ganga Rejuvenation, Ministry of Jal Shakti is giving 57 awards to States, Organizations, Individuals etc. in 11 different categories.
- These are: Best State, Best District, Best Village Panchayat, Best Urban Local Body, Best Media (Print & Electronic), Best School, Best Institution/RWA/Religious organization for Campus usage, Best Industry, Best NGO, Best Water User Association, and Best Industry for CSR Activity.

Background

- India's current water requirement is estimated to be around 1,100 billion cubic meters per year, projected to go up to 1,447 billion cubic meters by 2050.
- While India has more than 18% of the world's population, it has only 4% of world's renewable water resources.
- It is in this backdrop that the National

2 VS 2 AGRI MARKET ACCESS ISSUES


• In pursuant to the 12th India – USA TPF meeting held on 23 Nov, 2021 Department of Agriculture and farmer's welfare (DAC&FW) and US Department of Agriculture (USDA) have signed a framework agreement for implementing the 2 Vs 2 Agri market access issues.

About

- 2 Vs 2 Agri market access issues involves inspection / oversight transfer for Indian mangoes & pomegranate and market access for pomegranate arils from India and market access for US cherries and U.S Alfalfa hay.
- Mango and pomegranate exports will start from Jan – Feb 2022 and pomegranate aril exports from Apr 2022. Exports of Alfalfa hay and cherries from the USA will begin in Apr 2022.
- In addition, based on the ministerial discussions, Department of Animal Husbandry and Dairying (DAHD) also conveyed its readiness to provide market access for U.S pork and requested the U.S side to share a signed copy of final sanitary certificate for finalizing the same.

NATIONAL ATLAS & THEMATIC MAPPING ORGANISATION (NATMO)

 Visually challenged students from all over the country will have the access soon to Braille Maps designed and developed using Digital Embossing Technology, enabling them for ease of use, user friendly, better feeling and durable in terms of quality.



About

- The digital embossing technology is a technology which eliminates the need for printing plates, moulds, chemicals, and solvents, emitting no pollutants or waste and reduces overall energy usage.
- This innovative technology has been introduced, designed and implemented first time in India by National Atlas & Thematic Mapping Organisation (NATMO) functioning as the Attached Office of the Department of Science & Technology.
- The maps produced using this technology is not only useful for high-speed production of the maps but can also produce Braille Maps that can be used by more people for years together.
- NATMO started the journey in the year 1997, however, it has become popularized with the publication of Braille Atlas for Visually Impaired (India), edition 2017 in English Braille Script which received a huge response from the visually impaired community.
- Prime Minister Shri Narendra Modi

conferred National Award on "Science & Technology Intervention for Physically Challenged" to NATMO for this publication which was officially released on 10th February 2017 at New Delhi.

KHADI HANDMADE PAPER SLIPPERS

 The devotees visiting the Kashi Vishwanath Temple in Varanasi and hundreds of temple workers will no longer need to enter the temple premises barefoot.

- Starting 14th January, Khadi and Village Industries Commission (KVIC) is beginning the sale of Khadi handmade paper "Use & Throw" slippers for the use of the devotees and the workers.
- The slippers will be sold by Kashi Hastkala Pratisthan, a registered Khadi Institution in Varanasi.
- The development comes in wake of the jute slippers sent by the Prime Minister for the workers of Kashi Vishwanath Temple after he learnt that most of the people working at the temple performed their duty barefoot. It is forbidden to wear footwear made of leather or rubber on the temple premises.
- The "use & throw" slippers made of handmade paper will maintain the sanctity of the temple and at the same time will also save devotees from heat and cold during harsh weather conditions.
 Also, these slippers will prevent any kind of pollution as they are made of natural fibres.
- Notably, Khadi's handmade paper "use & throw" slippers have been developed for the first time in India. These handmade paper slippers are 100% eco-friendly and cost-effective.

 The Handmade paper used in making these slippers is completely wood-free and made of natural fibers like Cotton & Silk rags and agro waste and hence, suitable for use in places of worship.

WATER PURIFICATION

 Union Minister Dr. Jitendra Singh launched an Artificial Intelligencedriven Start-Up by IIT alumni for water purification through innovative technology.

About

- The facility aims to provide clean drinking water at a price much lesser than the market price.
- A MoU was also signed between Technology Development Board (TDB), a statutory body of Department of Science & Technology, Government of India and M/s Swajal Water Private Limited, a tech Start Up company founded by ex-IITians based in Gurugram.
- The company is focused on innovative technologies to make reliable clean drinking water accessible to communities at affordable price, for their project on IoT enabled point of use Solar Water Purification Unit for slums, villages and High Utility Areas.
- The Minister said, apart from the Centre's initiatives like National Rural Drinking Water Programme (NRDWP) and Jal Jeevan Mission, Private Sector should come forward in a big way with state of the art tech solutions to cover nearly 14 Crore households where clean drinking water is yet to reach.

INDU MALHOTRA COMMITTEE

 The Supreme Court has appointed former SC Judge, Indu Malhotra, as the Chairperson to head the inquiry committee, along with other members.

About

- The inquiry committee will look into the alleged security breach of Prime Minister's Punjab visit on 5th January this year.
- The committee headed by Justice (Retired) Indu Malhotra will also comprise DG- NIA, DG Security of Punjab and Registrar General of Punjab and Haryana High Court.
- The Apex court has passed the order after hearing a petition filed by NGO, Lawyers Voice, seeking appropriate directions and or orders in the alleged security breach of the Prime Minister, who was on his way to Punjab to address a rally.

STATE OF THE WORLD' SPECIAL ADDRESS

 Prime Minister Narendra Modi delivered 'State of the World' special address at the World Economic Forum's Davos Agenda.



- The Prime Minister said that today, India is providing a record number of software engineers. More than 50 lakh software developers are working in India.
- As compared to mere 100 start-ups in 2014, India has more than 60 thousand start-ups today. Out of which 80 are unicorns and more than 40 unicorns emerged in 2021 itself.

- He also talked about India's huge, safe and successful digital payments platform and informed that in the last month itself more than 4.4 billion transactions took place through Unified Payments Interface.
- India has deregulated areas like Drones, Space, Geo-spatial mapping and has brought reforms in the outdated telecom regulation related with the IT and BPO sectors.

 Department of Empowerment of Persons with Disabilities (Divyangjan) (DEPwD) is going to launch its first bi-monthly E-Newsletter during the inauguration of main building of Composite Regional Centre for Skill Development, Rehabilitation & Empowerment of Persons with Disabilities (CRC),

Kozhikode

About

- The function is being organized at CRC Campus at Chevayur, Kozhikode, Kerala.
- CRC in Kozhikode was established in 2012 by the Ministry of Social Justice and Empowerment, Government of India under the administrative control of National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD), Chennai (an autonomous Institute under the administrative control of DEPwD) as its outreach/ extension centre.
- At present, the services of the Centre are being operated from rented building with a total area of 5000 sq ft of space with 12 rooms available for services.
- Government of Kerala has allotted 3 acres of land at Chevayur, Kozhike in 2013 for establishment of CRC. This newly constructed building of CRC Kozhikode is a 48,000 sq. ft. structure, built at a cost of around 20 crores.

ACTIVISION BLIZZARD

 Microsoft Corp announced on January 18 that it would buy Activision Blizzard, the maker of superhit video games Call of Duty and Candy Crush, for \$68.7 billion in cash.

About



 This is the largest deal in the sector, and makes Microsoft, maker of the Xbox gaming console, the third-largest gaming company by revenue after Tencent and Sony, the company said.

- The acquisition underlines the importance Microsoft attaches to video games in the coming digital world dominated by virtual and augmented reality.
- The deal is expected to boost Microsoft against Facebook, the biggest player in the metaverse. By adding Activision, Microsoft is betting that people would want to play major games on not just phones, consoles, or computers, but also in VR.

NATIONAL COMMISSION FOR SAFAI KARAMCHARIS (NCSK)

 The Union Cabinet has approved the extension of the tenure of the National Commission for Safai Karamcharis (NCSK) for three years

About

- The total implication of the extension for three years would be approximately Rs. 43.68 crore.
- Impact: The major beneficiaries would be the Safai Karamcharis and identified manual scavengers in the country since the NCSK for 3 more years beyond 31.3.2022. The number of Manual Scavengers identified under the MS Act Survey as on 31.12.2021 is 58098.
- The NCSK was established in the year 1993 as per the provisions of the NCSK Act 1993 initially for the period upto 31.3.1997.
- Later the validity of the Act was initially extended upto 31.3.2002 and thereafter upto 29.2.2004. The NCSK Act ceased to have effect from 29.2.2004.
- After that the tenure of the NCSK has been extended as a non-statutory body from time to time through resolutions.
 The tenure of the present Commission is

upto 31.3.2022.

• As per the provisions of the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013, the NCSK has been assigned the work to monitor the implementation of the Act, tender advice for its effective implementation to the Centre and State Governments and enquire into complaints regarding contravention/non-implementation of the provisions of the Act

SOMNATH TEMPLE

 Prime Minister Narendra Modi will inaugurate the new Circuit House at Somnath



About

- Somnath Temple is visited by lakhs of devotees from India and abroad every year. The need for the new Circuit House was felt as the existing government facility was located far off from the temple.
- The new Circuit House has been built at a cost of over Rs 30 crore and is located near the Somnath Temple. It is equipped with top class facilities including suites, VIP and deluxe rooms, conference room, auditorium hall etc.

Note

 The Somnath temple, also called Somanātha temple or Deo Patan, is located in Prabhas Patan, Veraval in Gujarat, India.

- One of the most sacred pilgrimage sites for the Hindus, they believe it to be the first among the twelve Jyotirlinga shrines of Shiya.
- It was reconstructed several times in the past after repeated destruction by several Muslim invaders and rulers.
- After India's independence, those ruins were demolished and the present Somnath temple was reconstructed in the Māru-Gurjara style of Hindu temple architecture.
- The contemporary Somnath temple's reconstruction was started under the orders of the first Home Minister of India Vallabhbhai Patel and completed in May 1951 after his death.
- Presently the Prime Minister of India Narendra Modi is the chairman of Shree Somnath Mandir trust.

JUSTICE CLOCK

 Supreme Court e-Committee chairperson and SC judge Justice DY Chandrachud inaugurated two digital services for Gujarat High court — a 'Justice Clock', and electronic payment of court fee.

About

- What is the 'Justice Clock'?
- An LED display of 7 feet by 10 feet, placed at a height of 17 feet from the ground, has been erected at a busy crossroad near the Gujarat High Court premises.
- This 'Justice Clock' will exhibit vital statistics of the justice delivery system in Gujarat, to "maximise outreach and visibility" of the work done by the state judiciary.
- The interface has been designed and developed in-house and will display data

- from the National Judicial Data Grid (NJDG) in real-time.
- A similar format of Gujarat judiciaryrelated statistics will also be available on the Gujarat HC website under a tab of 'Virtual Justice Clock', accessible to all.
- What is e-court fee and how will it help?
- While the online e-Courts fee system was already available for the Gujarat High Court, which was tested on a pilot basis allowing advocate and parties to procure judicial stamps online through electronic payment and upon submission of a PDF receipt, this platform now stands expanded to all district and taluka courts.
- The payment platform is of StockHolding Corporation of India Ltd (SHCIL) as empanelled by the Gujarat government.
- A PDF receipt of the fee paid will be generated and submitted to the court registry concerned.
- It will then be verified from within the digital case information system and locked as 'consumed', wherein the receipt will be defaced, so as to avoid its reuse or misuse.

BANKING ON ELECTRIC VEHICLES IN INDIA

 NITI Aayog, Rocky Mountain Institute (RMI), and RMI India released a report, titled 'Banking on Electric Vehicles in India', which outlines the importance of priority-sector recognition for retail lending in the electric mobility ecosystem.

About

• The report provides considerations and recommendations to inform the inclusion of EVs in the Reserve Bank of India's (RBI's) priority-sector lending (PSL) guidelines.

- Banks and non-banking financial companies (NBFCs) in India have the potential to achieve an electric vehicle (EV) financing market size of Rs 40,000 crore (USD 5 billion) by 2025 and Rs 3.7 lakh crore (USD 50 billion) by 2030. However, retail finance for EVs has been slow to pick up.
- Priority-sector lending aims to expand financial access and support employment opportunities in India. In order to meet these goals, the report highlights that the RBI may consider various EV segments and use cases based on five parameters:
 - socio-economic potential,
 - livelihood generation potential,
 - scalability,
 - techno-economic viability, and
 - stakeholder acceptability.
 - The report indicates that electric two-wheelers, three-wheelers, and commercial four-wheelers are early segments to prioritize under PSL.

NATIONAL SINGLE WINDOW SYSTEM (NSWS)

 The Minister of Commerce and Industry Shri Piyush Goyal has said simplicity of operations and transparency should be the focus of the National Single Window System (NSWS).


About

- The digital platform of NSWS facilitates investors to identify and apply for approvals.
- It supports information across 32 Central Ministries/ Departments and the platform has 14 States onboard namely Andhra Pradesh, Assam, Goa, Gujarat, Himachal Pradesh, Karnataka, Madhya Pradesh,

- Maharashtra, Odisha, Punjab, Tamil Nadu, Telangana, Uttar Pradesh and Uttarakhand. The process for inclusion of 6 more States is in progress.
- The Know Your Approvals (KYA) service is live on the NSWS with 544 approvals across 32 Central Ministries/ Departments. A total of 3,259 approvals are listed.
- The first approval through the NSWS portal has been granted on 11 January 2022 to M/s CMR-Kataria Recycling Private Limited for the Vehicle Scrappage Facility RVSF, Kheda, Gujarat with a capacity of 67,000 vehicles.

AMAR JAWAN JYOTI

• The government has put out the eternal flame of the Amar Jawan Jyoti underneath India Gate and merged it with the one instituted at the National War Memorial in 2019 a few hundred meters away.



- The eternal flame at the Amar Jawan Jyoti underneath India Gate in central Delhi was an iconic symbol of the nation's tributes to the soldiers who have died for the country in various wars and conflicts since Independence.
- Established in 1972, it was to mark

India's victory over Pakistan in the 1971 War, which resulted in the creation of Bangladesh. The then Prime Minister India Gandhi had inaugurated it on Republic Day 1972, after India defeated Pakistan in December 1971.

- The key elements of the Amar Jawan Jyoti included a black marble plinth, a cenotaph, which acted as a tomb of the unknown soldier. The plinth had an inverted L1A1 self-loading rifle with a bayonet, on top of which was a soldier's war helmet.
- The installation had four urns on it, with four burners. On normal days one of the four burners were kept alive, but on important days like the Republic Day, all four burners were lit. These burners were what is called the eternal flame, and it was never allowed to be extinguished.
- For 50 years the eternal flame had been burning underneath India Gate, without being extinguished. But on Friday, the flame was finally put off, as it was merged with another eternal flame at the National War Memorial.
- Since 1972, when it was inaugurated, it used to be kept alive with the help of cylinders of liquified petroleum gas, or LPG. One cylinder could keep one burner alive for a day and a half.
- In 2006 that was changed. Though a
 project that cost around Rs 6 lakh the fuel
 for the flames was changed from LPG to
 piped natural gas, or PNG. It is through
 this piped gas that the flame marking the
 tribute to Indian soldiers had been kept
 alive eternally.

DEEP OCEAN MISSION

Chief of the Naval Staff, Admiral R.
 Hari Kumar called on Union Minister

Dr Jitendra Singh and discussed the modalities to deepen cooperation in "Deep Ocean Mission" which is to be the torchbearer of India's "Blue Economy"

About

- The Modi Government had approved the Deep Ocean Mission (DOM) in June, 2021 to be implemented by the Ministry of Earth Sciences at a total budget of Rs. 4077 Crore for 5 years.
- DOM is a multi-ministerial, multi-disciplinary programme with emphasis on development of deep-sea technology that includes development of manned Submersible rated for 6000 metre water depth along with technologies for deep sea mining, exploration of deep-sea mineral resources and marine biodiversity, acquisition of a research vessel for ocean exploration, deep sea observations, and capacity building in Marine Biology.

Role of Indian Navy

- The Indian Navy is a member of Deep Ocean Council and it will be involved in launching and recovery of Man submersible in deep water, which will be developed under the Deep Ocean Mission.
- The Ministry of Earth Sciences and Indian Navy are to soon sign a MoU for knowledge sharing in the areas of design and development of underwater vehicles.

MATSYA

- Dr Jitendra Singh informed that the preliminary design of the manned submersible MATSYA 6000 is completed and realisation of vehicle is started with various organization including ISRO, IITM and DRDO roped-in to support the development.
- It is designed to carry 3 people to a depth of 6000 metres in the ocean with suit of

scientific sensors and tools.

Samundrayaan

- Dr Jitendra Singh launched India's First Manned Ocean Mission Samundrayaan at Chennai in October, 2021 and thus joined the elite club of nations such as USA, Russia, Japan, France and China to have such underwater vehicles for carrying out subsea activities.
- This niche technology shall facilitate Ministry of Earth Sciences, MoES in carrying out deep ocean exploration of the non-living resources such as polymetallic manganese nodules, gas hydrates, hydro-thermal sulphides and cobalt crusts, located at a depth between 1000 and 5500 metres.

INDIAN TECH START-UP ECOSYSTEM: YEAR OF THE TITANS

 Start-ups raised a record \$24.1 billion in 2021, a two-fold increase over pre-COVID-19 levels, according to a new study by NASSCOM and Zinnov.

About

- According to the study, 'Indian Tech Start-up Ecosystem: Year of The Titans', more that 2,250 start-ups were added in 2021, over 600 more than what was added in the previous year.
- The study said: "Start-ups raised USD 24.1 billion in 2021, a two-fold increase over pre-COVID levels. In comparison to 2020, there was a 3X increase in the number of high value deals (deals > USD 100 million), demonstrating investor confidence with a pool of active angel investors of 2400+ and a readiness to take significant risks."
- It added that while the U.S. remains

- the leading source of foreign direct investment (FDI) in start-ups, worldwide involvement is also growing. About 50% of the deals had at least one Indiadomiciled investor.
- The study added that the start-up ecosystem saw a 2X gain in cumulative valuation from 2020 to 2021, with an estimate of \$320-\$330 billion, demonstrating the sector's development and recovery throughout the pandemic.
- The industries that saw the most net new job creation were BFSI (banking, financial services and insurance), edtech, retail and retail tech, food-tech, supply chain management, and logistics and mobility.
- On the back of Internet commerce, freelancers, and service industries, indirect jobs have also recovered.

LIVING ROOT BRIDGES OF MEGHALAYA

 The Zoological Survey of India has underlined some green rules for the living root bridges of Meghalaya to get the UNESCO World Heritage Site tag. Meghalaya CM Conrad K. Sangma pitched for UNESCO recognition as the hill State marked its 50th year of creation.

About



 A living root bridge is like a suspension bridge formed by guiding the pliable roots of the rubber fig tree (Ficus elastica) across a stream or river and allowing the roots to grow and strengthen over time.

• They are common in the southern part of the Northeast Indian state of Meghalaya.

ABIDE WITH ME

 A day after the eternal flame at Amar Jawan Jyoti was shifted to the National War Memorial, the government has dropped Abide With Me, the sombre highpoint of the conclusion of the Republic Day celebrations.

About

- Penned in the pre-modern world by Henry Francis Lyte, a Scottish Anglican minister and son of a naval captain, the hymn, which is known for its simplicity and sombre theme, is often sung to English composer William Henry Monk's evocative tune Eventide, and has been a fixture in the Indian Beating Retreat ceremony since 1950.
- It is always the last piece to be played by the brass bands before the troops recede up Raisina Hill to the tune of poet Allama Iqbal's Saare jahan se achha.
- Played at dusk, this is also the last piece before the retreat buglers bring down the Indian flag.
- In 2020, reports had emerged about the hymn being dropped from the Beating Retreat Ceremony and being replaced by poet Bankim Chandra Chatterjee's Vande Mataram. Following criticism, the hymn was played in 2020 and retained in 2021.

View of Gandhi

- Abide With Me was one of Mahatma Gandhi's personal favourites. The Father of the Nation first heard the piece played by Mysore Palace Band, and could not forget its tenderness and serenity.
- At Sabarmati Ashram in Ahmedabad,

the ashram bhajanavali — the first and probably the only cross-religion hymnal anywhere — with the bhajans 'Vaishnav Jan Toh' and the well-known Ram Dhun by Tulsidas, 'Raghupati Raghav Raja Ram' in it, Abide With Me, along with Lead Kindly Light, was put together under Gandhi's watch.

Aye Mere Watan Ke Logon

- Abide With Me has been replaced by Kavi Pradeep's seminal piece Aye Mere Watan Ke Logon, which was written in the wake of the Sino-Indian War, and went on to become a tableau of Indian nationalism.
- The song was first sung on January 27, 1963. Composed by C Ramachandra and sung by Lata Mangeshkar, it was first performed at Delhi's National Stadium in a fundraiser organised by the film industry for Indian war widows

CONSTRUCTION OF ADI BADRI DAM

- Governments of Himachal Pradesh and Haryana have signed an MoU at Panchkula, for the construction of Adi Badri Dam that would come upon 77 acres in Himachal Pradesh near the Adi Badri area of Yamuna Nagar district of Haryana.
- The proposed dam aims for the rejuvenation of the Saraswati river

BLOCK CHAIN TECHNOLOGY

- During the function, PM Modi gave digital certificates to the 61 winners of PMRBP 2021 and 2022 using a Block Chain-driven technology developed by IIT Kanpur under the National Blockchain Project.
- The digital certificates are stored on digital wallets installed on the mobile

devices of the recipients.

- The digital certificates issued using the blockchain driven technology are unforgeable, globally verifiable, selectively disclosable and sensitive to user content.
- Block Chain Technology is being used for the first time for giving certificates to the awardees.

PROJECT MONITORING GROUP (PMG) PORTAL

 Minister of Commerce & Industry Piyush Goyal reviewed the pace of implementation of infrastructure projects being monitored through the Project Monitoring Group (PMG) portal.

About

- PMG portal of Invest India is a unique institutional mechanism to facilitate resolution of bottlenecks in infrastructure projects with investments upward of ₹ 500 crores and do milestone-based project monitoring of the same.
- Projects of infrastructure ministries such as Road, Transport and Highways; Railways; Petroleum and Natural Gas; New and Renewable Energy; Power; etc are listed on the portal.
- The PMG mechanism allows project proponents to raise issues with concerned government agencies which are causing hindrances in implementation of projects.
- Presently, PMG is monitoring 1,351 under implementation projects with total anticipated investment of approximately INR 48.94 lakh crore.
- Issues raised on PMG portal pertain primarily to land acquisition (about 40%); grant of right of use/ right of way (25%); and forest, environment and

wildlife clearances (14%).

 In 2021, PMG also incorporated milestone based monitoring of projects. This feature will allow for forecasting delays in projects to avoid time and cost overruns and identify agencies and authorities responsible for delays.

AIR INDIA

• The Air India strategic disinvestment transaction has been completed with Government receiving a consideration of Rs 2,700 crore from the Strategic Partner (M/s Talace Pvt Ltd, a wholly owned subsidiary of M/s Tata Sons Pvt Ltd), retaining debt of Rs 15,300 crore in Air India and AIXL and transferring shares of Air India (100% shares of Air India and its subsidiary AIXL and 50% shares of AISATS) to the Strategic Partner.

About

- It is pertinent to mention that following Government's approval of the highest price bid of M/s Talace Pvt Ltd for strategic disinvestment of Air India, the Letter of Intent was issued to the winning bidder on 11 October 2021.
- The Share Purchase Agreement (SPA) was signed on 25 October, 2021.
 Thereafter, Strategic Partner (M/s Talace Pvt Ltd), Air India and the Government worked towards satisfying a set of conditions precedent defined in the SPA including approvals from anti-trust bodies, regulators, lenders, third parties, etc.
- These conditions have since been met to mutual satisfaction.

ZAID CROPS

• Union Agriculture Minister addressed the 4th National Conference on Agriculture

About

- Union Agriculture Minister said that summer crops not only provide extra income but also create employment opportunities in between Rabi and Kharif for the farmers thereby increasing crop intensity.
- The Government has taken new initiatives through various programmes for cultivation of summer crops such as pulses, coarse cereals, nutri-cereals, and oilseeds.
- He highlighted that area under cultivation of zaid crops including rice has increased progressively 2.7 times from 29.71 lakh hectares in 2017-18 to 80.46 lakh hectares in 2020-21.
- The objective of Zaid conference is to review and assess the crop performance during the preceding crop seasons and fix crop-wise targets for summer season in consultation with State Governments.

Zaid crops

- Zaid crops are summer season crops.
 They grow for a short time period between kharif and rabi crops, mainly from March to June.
- They require warm dry weather as major growth period and longer day length for flowering.
- Some of the crops produced during zaid season are watermelon, muskmelon, cucumber, vegetables and fodder crops.

NATIONAL INSTITUTE OF PHARMACEUTICAL EDUCATION AND RESEARCH (NIPER)

• Union Minister for Chemicals and Fertilizers Shri Mansukh Mandaviya launched NIPER Research Portal.

About

- National Institute of Pharmaceutical Education and Research (NIPER) Research Portal has been created with the aim to disseminate the information about all the NIPERs and their research activities, patents filed and Publication information at one place so that a industry and other stakeholders know about them.
- National Institute of Pharmaceutical Education and Research (NIPERs) are a group of national level institutes of pharmaceutical sciences in India.
- The Government of India has declared the NIPERs as Institutes of National Importance.
- They operate as autonomous bodies under the aegis of Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers.

Established in: 1998

 They are located in 7 cities in India: Ahmedabad, Guwahati, Hajipur, Hyderabad, Kolkata, S.A.S. Nagar and Raebareli.

VILLAGES OF EXCELLENCE

• Union Minister of Agriculture and Farmers Welfare Shri Narendra Singh Tomar expressed happiness on the completion of 30 years of diplomatic relations between India and Israel.

About

 The Minister expressed satisfaction at the functioning of 29 Centers of Excellence in 12 States which are producing more than 25 million vegetable plants, over 387 thousand quality fruit plants and can train more than 1.2 lakh farmers per year.

- Union Minister Shri Tomar informed that it has been decided to convert 150 villages around the Centers of Excellence into Villages of Excellence with technical assistance from Israel, out of which 75 villages are being taken up in the first year to commemorate the 75th year of India's independence where India and Israel will work together.
- These Centers of Excellence (CoEs) are a great example of cooperation between the two countries.

TIWA COMMUNITY

 Almost 250 members of two extremist organisations in Assam laid down their arms before Chief Minister Himanta Biswa Sarma at a formal programme in Guwahati.



About

- The organisations are the Tiwa Liberation Army (TLA) and the United Gorkha People's Organisation (UGPO).
- Formed in 2014 to cater to the aspirations of the Tiwa community, the TLA was active in Morigaon, Nagaon and West Karbi Anglong districts of central Assam.
- The UGPO, formed in 2007, was mostly active in the Bodoland Territorial Region and Biswanath district.

Important Info

Tiwa

• Tiwa (Lalung) is an ethnic group mainly

- inhabiting the states of Assam and Meghalaya in north-eastern India.
- They are also found in some areas of Arunachal Pradesh, Manipur and Nagaland.
- They are recognized as a Scheduled tribe within the State of Assam.
- They were known as Lalungs in the Assamese Buranjis and in Colonial literature and in the Constitution of India, though members of the group prefer to call themselves Tiwa (meaning "the people who were lifted from below").

SWACHHATA START-UP CHALLENGE

 Ministry of Housing & Urban Affairs (MoHUA), Government of India, in partnership with Department of Promotion of Industry and Internal Trade (DPIIT) and Agence Française de Développement (AFD) launched the Swachhata Start-Up Challenge.

About

- It aims to provide an impetus to innovative start-ups to come forward and drive catalytic transformation in the sanitation and waste management sector.
- The Challenge seeks to promote an enabling environment for enterprise development under Swachh Bharat Mission-Urban 2.0 (SBM-U 2.0).



 The Swachhata Start-Up Challenge launched today aims to capitalise on the start-up movement by providing opportunities for entrepreneurship to

- young innovators to create socially impactful and market ready business solutions.
- The Challenge, which is open to startups registered in India and French actors collaborating with an Indian start-up (as a joint venture), invites solutions across four thematic areas viz. (i) social inclusion, (ii) zero dump (solid waste management), (iii) plastic waste management and(iv) transparency through digital enablement.

CONDITIONAL MARKET AUTHORIZATION

 The National Regulator, Drugs Controller General of India (DCGI), has given nod to market authorization of two COVID19 vaccines, Covaxin and Covishield subject to certain conditions.

About

• The Subject Expert Committee (SEC) of the Central Drugs Standard Control Organization (CDSCO) had recommended for upgradation of status for the vaccines from restricted use in emergency situations to grant of new drug permission with conditions in the adult population on 19th January 2022.



- The market authorization of two COVID19 vaccines, Covaxin and Covishield, in the country by DCGI is subject to the following conditions:
- Firm shall submit data of overseas

- ongoing clinical trials of the product with due analysis on six monthly basis or as and when available, whichever is earlier.
- The vaccine shall be supplied for programmatic setting and all vaccinations done within the country to be recorded on CoWIN platform and Adverse Event Following Immunization [AEFI], Adverse Event of Special Interest [AESI] shall continue to be monitored.

Important Info

- "Conditional Market Authorization" is a new category of market authorization that has emerged during the current global pandemic of COVID19.
- The approval pathways through this route are fast-tracked with certain conditions to enhance the access to certain pharmaceuticals for meeting the emerging needs of drugs or vaccines.
- It may be noted that of the global Stringent Regulatory Authorities, only the United States Food and Drug Administration (USFDA) Medicines and Healthcare products Regulatory Agency (MHRA) of the UK have granted "conditional market authorization" to Pfizer and AstraZeneca, respectively, for their COVID19 Vaccines.

FAMILY PENSION

 Union Minister of Personnel, Public Grievances, Pensions Jitendra Singh said that mentally retarded child of a deceased Government employee/Pensioner is entitled to Family Pension and the spirit of this provision needs to be understood and respected.

About

 This reiteration was necessitated by the fact that it has come to the notice of the Department of Pension & Pensioners' Welfare that in some cases the Banks are not allowing Family Pension in respect of a mentally retarded child through the person nominated by the Pensioner or his/her spouse and they insist for a Guardianship Certificate issued by a Court of Law.

- The provision for nomination for Family Pension is intended to avoid any hassle to the child suffering from a mental disability in obtaining Guardianship Certificate from the Court or in claiming Family Pension after the death of his/her parents.
- Therefore, insisting for a Guardianship Certificate by a Bank in such cases defeats the very purpose of such nomination and also amounts to violation of the statutory provisions of Central Civil Service (Pension) Rules, 2021.
- The Department has, therefore, reiterated the provisions of the above rules.

SPMCIL OPENS NEW BANK NOTE PRINTING LINES AT NASHIK AND DEWAS

Security Printing and Minting Corporation of India Limited (SPMCIL) has set up 'new banknote printing lines' at its Currency Note Press, Nashik and Bank Note Press, Dewas. In India, four printing presses for printing and supply of Banknotes. These are at Dewas in Madhya Pradesh, Nasik in Maharashtra (owned by SPMCIL), Mysore in Karnataka, and Salboni in West Bengal (owned by Bharatiya Reserve Bank Note Mudran Private Limited (BRBNMPL))

About the SPMCIL

 SPMCIL, a Government of India owned Miniratna company, is engaged in the manufacture/production of Currency and Bank Notes, Security Paper, Non-Judicial Stamp Papers, Postal Stamps, Passport, Visa, Cheques, Bond, Warrant, Special Certificates with security features, Security Inks, Circulation & Commemorative Coins, Medallions, Refining of Gold & Silver, and Assay of Precious Metals among others.

VEER BAAL DIWAS

• Prime Minister of India, Narendra Modi has declared that starting from the year 2022, December 26 will be observed as 'Veer Baal Diwas' every year. The day will be commemorated as a tribute to the courage of the 4 Sahibzades (the four sons of Guru Gobind Singh Ji), who attained martyrdom in the 17th century.

History of the day

• 26 December marks the day on which Sahibzada Zorawar Singh Ji and Sahibzada Fateh Singh Ji (younger pair of Sahibzade) attained martyrdom after being sealed alive in a wall, at the tender age of 6 and 9 years. Sahibzada Ajit Singh Ji and Sahibzada Jujhar Singh Ji (older pair of Sahibzade) attained martyrdom on December 21, 1705, fighting the enemy in battle at Chamkaur Sahib at the young age of 18 and 14 years.



COLLECTIVE SECURITY TREATY ORGANIZATION (CSTO)

 A Moscow-led military alliance dispatched troops to help quell mounting unrest in Kazakhstan as the police said dozens were killed trying to storm government buildings.


Key facts

 The Collective Security Treaty Organization (CSTO) is an intergovernmental military alliance in Eurasia that consists of select post-Soviet states.

- Membership: Armenia, Belarus, Kazakhstan, Kyrgyzstan, Russia and Tajikistan.
- Headquarters: Moscow, Russia.

NATURAL GAS HYDRATE

 Bangladesh has discovered huge potential natural gas hydrate deposits of 0.11 to 0.73 trillion cubic feet (TCF) in its exclusive economic zone area.



- It is equivalent to 17-103 TCF of natural gas reserves. The finding of the huge reservoir of the natural gas hydrate is a landmark event in resolving the energy crisis in future.
- The production technology of methane gas from the hydrates is fundamentally different from the extraction of oil and natural gas which flows naturally through the pores of the reservoirs to the well.
- Hydrates are solids and need to be dissociated through techniques like hot water pumping, depressurisation and Carbon Dioxide injection to release the methane gas from the hydrates.
- Work is going on in the world to develop economically viable technology to extract gas from the hydrates.

DEVELOPING COUNTRY STATUS (WTO)

China's status as a 'developing country' at the World Trade Organization (WTO) has become a contentious issue with a number of countries raising concerns over the upper middle-income nation deriving benefits reserved for developing countries under WTO norms.

About

- What are the benefits of 'developing country' tag?
- Certain WTO agreements give developing countries special rights through 'special and differential treatment' (S&DT) provisions, which can grant developing countries longer timeframes to implement the agreements and even commitments to raise trading opportunities for such countries.
- WTO pacts are often aimed at reduction in government support to certain industries over time and set more lenient target for

- developing nations and grant them more time to achieve these targets compared to developed ones.
- The classification also allows other countries to offer preferential treatment.
- How is a 'developing country' decided?
- The WTO has not defined 'developed' and 'developing' countries and therefore member countries are free to announce whether they are 'developed' or 'developing

LEAST DEVELOPED COUNTRY' (LDC) STATUS

• Concerns have been raised at the World Trade Organization (WTO) over the 'least developed country' (LDC) status, with Bangladesh potentially losing this tag after surpassing India in terms of GDP per capita.

About

- Benefits of LDC classification?
- The WTO recognises LDCs relying on a classification by the UN based on a criteria that is reviewed every three years.
 LDCs are often exempted from certain provisions of WTO pacts.
- Bangladesh, currently classified as an LDC, receives zero duty, zero quota access for almost all exports to the EU.
- It is, however, set to graduate from the LDC status in 2026 as its per capita GDP has risen sharply surpassing that of India in FY21.

INDIA-SOUTH KOREA TRADE RELATIONS

 Minister for Trade of South Korea, Yeo Han-Koo met with Commerce and Industry Minister Piyush Goyal in New Delhi.

About

- Both the Ministers held wide-ranging discussions covering the whole gamut of Bilateral Trade and Investment related aspects.
- The Ministers agreed to impart fresh momentum to the discussions on Comprehensive Economic Partnership Agreement up-gradation negotiations.
- India and Korea aim to achieve the trade target of 50 Billion dollars before 2030.
- They agreed to address difficulties expressed by industry from both sides and instructed their respective negotiating teams to meet on a regular basis in order to conclude the CEPA up-gradation negotiations as soon as possible.
- The Ministers agreed to boost bilateral trade between India and Korea to achieve growth in a fair and balanced manner to the mutual advantage of both sides.

INDIA-UK FTA

India and UK Launch Free Trade Agreement Negotiations.

About

- The FTA is expected to facilitate the target of doubling bilateral trade between India and United Kingdom by 2030, set by the Prime Ministers of both the nations, Shri Narendra Modi and Mr. Boris Johnson in May 2021.
- The FTA with UK is expected to provide certainty, predictability and transparency and will create a more liberal, facilitative and competitive services regime.
- The FTA negotiations with the UK is expected to increase our exports in Leather, Textile, Jewellery and processed Agri products.

- India is also expected to register a quantum jump in the export of Marine Products through the recognition of 56 marine units of India.
- The Mutual Recognition Agreements (MRAs) on Pharma could provide additional market access. There is also great potential for increasing exports in service sectors like IT/ITES, Nursing, education, healthcare, including AYUSH and audio-visual services. India would also be seeking special arrangements for movement of its people.

NATO-RUSSIA COUNCIL (NRC)

The North Atlantic Treaty Organisation (NATO) and Russia discussed the ongoing situation in Ukraine and its implications for security in Europe.

- The talks happened at the NATO-Russia Council (NRC) which took place at the NATO headquarters in Brussels.
- NRC is a forum for consultation with Russia on security issues and cooperation.
- NATO was founded in 1949, and is meant to ensure collective protection for its members the United States, Canada, and American allies in Europe against the threat of possible post-War communist expansion and aggression by the Soviet Union.
- The Soviet Union too, formed its own defence and political alliance with Eastern European nations as a counterbalance to NATO—the Warsaw Pact that was signed in 1955. This alliance was disbanded after the dissolution of the Union of Soviet Socialist Republics (USSR) in 1991.
- Since April 2014, practical civil and military cooperation under the NRC with Russia has been suspended.

- This happened in response to Russia's military intervention in Ukraine and its annexation of Crimea from Ukraine, which NATO allies do not recognise and have referred to as "illegal" and "illegitimate".
- This was the first time since WWII that a European nation had annexed territory from another country. The region that Russia annexed in 2014 is now under Russian-backed separatists and even today fighting continues there.

BILATERAL TRADE BETWEEN INDIA, CHINA

Bilateral trade between India and China crossed 125 billion USD in 2021, according to Chinese customs data released.

About

- Despite a protracted border standoff, Two-way trade between India and China in 2021 stood at 125.66 billion USD, up 43.3% from 2020 when bilateral trade was worth 87.6 billion USD.
- In 2021, China's exports to India were 97.52 billion USD, up 46.2%, while China imported 28.14 billion USD worth of goods from India, up 34.2%, according to statistics released by the General Administration of Customs (GAC).
- Trade deficit between the two countries remained in favour of China – at \$69 billion. The deficit in trade has been a constant source of friction between New Delhi and Beijing, with India complaining that China hasn't given Indian companies access to sectors like pharmaceuticals.
- The widening trade deficit with China can be attributed to two factors: narrow basket of commodities, mostly primary, for exporting to China and the lack of market access for most India's agricultural

- products and the sectors where India is competitive in, such as pharmaceuticals, and IT.
- The USA maintained its place as China's third-largest trade partner following ASEAN and the European Union.
- In pre-pandemic times in 2019, the bilateral trade was 92.8 billion USD and both countries were aspiring to touch the mark of 100 billion USD. Due to COVID, India-China trade in 2020 declined to 87.6 billion USD, the lowest since 2017.

HUNGA TONGA



 The Pacific country of Tonga experienced a large volcanic eruption followed by a tsunami that flooded parts of the capital, Nuku'alofa, which is lies just 65km north of the volcano.

- The eruption of the Hunga Tonga-Hunga Ha'apai volcano sent shockwaves across the South Pacific.
- Hunga Tonga—Hunga Ha'apai is a volcanic island in Tonga, located about 30 km south of the submarine volcano of Fonuafo'ou and 65 km north of Tongatapu, the country's main island.
- The volcano is part of the highly active Tonga–Kermadec Islands volcanic arc, a subduction zone extending from New Zealand north-northeast to Fiji.

• The island arc is formed at the convergent boundary where the Pacific Plate subducts under the Indo-Australian Plate.

INDIA-SRI LANKA RELATIONS

India confirmed a \$400 million currency swap with Sri Lanka while deferring another \$500 million due for settlement to the Asian Clearing Union (ACU), in a move aimed at helping the island nation witnessing an unprecedented economic crisis.

About

- India's assistance follows a request from Sri Lanka during Finance Minister Basil Rajapaksa's visit to New Delhi in December, for emergency financial assistance, including Lines of Credit for importing essentials and a currency swap to boost Sri Lanka's draining foreign reserves.
- Sri Lanka is facing a severe dollar crunch that economists say might lead to a default on external debt and create a food shortage in the imports-reliant nation.
- Colombo must service over \$7 billion outstanding debt in 2022, including bond repayments of \$500 million in January and \$1 billion in July.
- In July 2020, the RBI extended a similar swap facility of \$400 million to help Sri Lanka cope with the impact of the first wave of the pandemic, and later provided a three-month roll over until February 2021, when the Central Bank of Sri Lanka settled it.
- The recent announcement on RBI assistance includes deferring the payment of \$500 that Sri Lanka owes to the ACU, a regional initiative with the Central Banks and Monetary Authorities of Bangladesh, Bhutan, India, Iran, Maldives, Myanmar, Nepal, Pakistan and Sri Lanka.

• Significantly, India's confirmation of the swap comes a week after the two countries signed a long-pending agreement on jointly developing the strategically located Trincomalee oil tank farm along the north-eastern coast of the island.

NUSANTARA

 Indonesia's parliament passed a law approving the relocation of its capital from slowly sinking Jakarta to a site 2,000 kilometres away on the jungleclad Borneo island that will be named "Nusantara".

- The House of Representatives vote provides the legal framework for the move, which was first tipped by President Joko Widodo in April 2019, citing rising sea levels and severe congestion on densely populated Java island.
- Home to more than 30 million people in its greater metro area, Jakarta has long been plagued by serious infrastructure problems and flooding exacerbated by climate change.
- The new capital will cover about 56,180 hectares in East Kalimantan province on the Indonesian part of Borneo.

INDIA-DENMARK COOPERATION ON GREEN FUELS

India & Denmark agreed to initiate joint research and development on green fuels including green hydrogen, during the Joint S&T Committee meeting on 14th January 2022.

About



- The Joint Committee discussed national strategic priorities and developments in Science, Technology, and Innovation of both countries with a special focus on green solutions of the future - strategy for investments in green research, technology, and innovation at the virtual meeting.
- The committee emphasised on development of bilateral collaboration on mission-driven research, innovation, and technology development, including climate and green transition, energy, water, waste, food, and so on as agreed by the two Prime Ministers while adopting the Green Strategic Partnership Action Plan 2020-2025.

FOURTH ASIA MINISTERIAL CONFERENCE ON TIGER CONSERVATION

Minister for Environment, Forest and Climate Change, Bhupender Yadav delivers India's statement at the Fourth Asia Ministerial Conference on Tiger Conservation, an important event for reviewing progress towards the Global Tiger Recovery Programme and commitments to tiger conservation.

- The Government of Malaysia and Global Tiger Forum (GTF) organized the 4th Asia Ministerial Conference on tiger conservation. India is one of the Founding members of the intergovernmental platform of Tiger Range Countries Global Tiger Forum.
- He appreciated the efforts of the Government of Malaysia in creating a role model for mitigation measures with respect to linear infrastructure in tiger habitat, in the form of "Central Spine and landscape level planning.
- The Minister said that India will facilitate Tiger Range Countries towards finalisation of New Delhi declaration for the Global Tiger Summit to be held at Vladivostok, Russia later this year.
- A "Pre-Tiger Summit" meeting was held at New Delhi in 2010, wherein the draft declaration on tiger conservation for Global Tiger Summit was finalised.
- India has achieved the remarkable feat of doubling the tiger population in 2018 itself, 4 years ahead of the targeted year 2022.
- He informed that the model of success of India's tiger governance is now being replicated for other wildlife like the Lion, Dolphin, Leopard, Snow Leopard and other small wild cats, while the country is on the threshold of introducing Cheetah in its historical range.
- The budgetary allocation for tiger conservation has increased from Rs 185 crore in 2014 to Rs 300 crore in 2022 and informed that 14 Tiger Reserves in

India have already been awarded with international CA|TS accreditation and efforts are on to bring in more Tiger Reserves under CA|TS accreditation.

INDIA-CENTRAL ASIA VIRTUAL SUMMIT

 Prime Minister Narendra Modi hosted the first India-Central Asia Summit in virtual format on 27 January 2022, which was attended by Presidents of the Republic of Kazakhstan, Kyrgyz Republic, Republic of Tajikistan, Turkmenistan and Republic of Uzbekistan.

About

- This first India-Central Asia coincided with the 30th anniversary of establishment of diplomatic relations between India and Central Asian countries.
- During the Summit, the Leaders agreed to institutionalize the Summit mechanism by deciding to hold it every 2 years.
- They also agreed on regular meetings of Foreign Ministers, Trade Ministers, Culture Ministers and Secretaries of the Security Council to prepare the groundwork for the Summit meetings.
- An India-Central Asia Secretariat in New Delhi would be set up to support the new mechanism.
- The Leaders discussed far-reaching proposals to further cooperation in areas of trade and connectivity, development cooperation, defence and security and, in particular, on cultural and people to people contacts.

INDIA-ASEAN DIGITAL WORK PLAN 2022

The 2nd ASEAN Digital Ministers (ADGMIN) meeting with India was held on a virtual platform.



- The ADGMIN is an annual meeting of Telecom Ministers of 10 ASEAN (Association of South-East Asian Nations) countries -Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand, and Vietnam and dialogue partner countries Australia, Canada, China, EU, India, Japan, Republic of Korea, New Zealand, Russia, UK and US.
- The meeting discussed and deliberated various matters relevant to strengthening regional digital cooperation in the spirit of digital inclusion and integration.
- The Ministers meeting approved the India-ASEAN Digital Work Plan 2022.
- The workplan includes system for combating the use of stolen and counterfeit mobile handsets, WiFi Access network interface for nationwide public internet, the capacity building and knowledge sharing in emerging areas in the field of Information and Communication Technologies such as Internet of Things (IoT), 5G, Advanced Satellite etc.

INDIA-OMAN DEFENCE RELATIONS

India is laying out the red carpet for Oman's top defence official Mohammed Nasser Al Zaabi, who will be in India from January 30 to February 4 on an official visit.

- Zaabi will be in Delhi to co-chair the Joint Military Cooperation Committee (JMMC) with Defence Secretary Ajay Kumar.
- The JMCC is the highest forum of engagement between India and Oman in the field of defence that evaluates and provides guidance to the overall framework of defence exchanges between the two sides.
- The JMCC is expected to meet annually, but could not be organised since 2018 when the meeting of the 9th JMCC was held in Oman.
- Why is Oman important from a defence and strategic point of view?
- Oman is India's closest defence partner in the Gulf region and an important anchor for India's defence and strategic interests.
- Defence cooperation has emerged as a key pillar for the robust India-Oman strategic partnership. Defence exchanges are guided by a Framework MOU which was recently renewed in 2021.
- Oman is the only country in the Gulf region with which all three services of the Indian armed forces conduct regular bilateral exercises and staff talks, enabling close cooperation and trust at the professional level. Oman also provides critical operational support to Indian naval deployments in the Arabian sea for anti-piracy missions.

- Bilateral training cooperation between the two sides is also robust with Omani forces regularly subscribing to training courses in India both at professional as well as higher command level.
- Indian armed forces also subscribe to the Staff and Command courses conducted at NDC, Oman. Oman also actively participates in the Indian Ocean Naval Symposium (IONS).




GDP GROWTH

 India's gross domestic product (GDP) is expected to grow by 9.2% in the current financial year following last fiscal's 7.3% contraction, the National Statistical Office (NSO) said in its first advance estimates of economic output released, amid concerns over the likely impact of a third wave of the COVID-19 pandemic.

About

- The NSO, however, made clear that these were "early projections" that did not factor in actual performance of various indicators as well as measures that may be taken to contain the spread of the pandemic.
- GDP at constant prices (2011-12) in the year 2021-22 is estimated at ₹147.54 lakh crore, as against the provisional estimate of GDP for the year 2020-21 of ₹135.13 lakh crore, adding that growth in real GDP is pegged at 9.2%.
- Real GVA at Basic Prices is estimated at ₹135.22 lakh crore in 2021-22, as against ₹124.53 lakh crore in 2020-21, showing a growth of 8.6%.
- The implicit GDP growth of 5.6% for H2 FY2022 built in by the NSO may not fully factor in the admittedly evolving impact of Omicron," said Aditi Nayar, chief economist at ICRA Ltd.
- Our sense is that after a 6.0-6.5% rise in Q3 FY2022, the GDP expansion is set to slip below 5% in the ongoing quarter.



• The NSO's GVA estimates show the mining sector outpacing others with growth of 14.3% following last year's 8.5% contraction, followed by manufacturing which is seen expanding by 12.5% after shrinking 7.2% in the previous 12-month period.

UN PROJECTS INDIA GDP AT 6.5% IN FY22

- The GDP growth forecast of India in fiscal 2022 is estimated to grow at 6.5 per cent as per the United Nations World Economic Situation and Prospects (WESP) 2022 report.
- On a calendar year basis UN has projected India's GDP as follows:

BAD BANK

A key proposal announced in 2021 Budget, a bad bank to deal with stressed assets in the loss-laden banking system, has received all regulatory approvals.



What is the structure of the bad bank?

- NARCL will acquire and aggregate the identified NPA accounts from banks, while IDRCL, under an exclusive arrangement, will handle the debt resolution process, State Bank of India Chairman Dinesh Khara said.
- Padmakumar Nair, a Chief General Manager from SBI's Stressed Assets vertical, will manage NARCL, while Manish Makharia, Head of Alternate Investment Fund, SBI Funds Management Pvt Ltd, will head IDRCL.
- Subrata Biswas, the nominee director on the Board of NARCL, will be the interim Chairman, and Diwakar Gupta will continue as the Chairman of IDRCL.
- Majority-owned by state-owned banks, the NARCL will be assisted by the India Debt Resolution Company Ltd (IDRCL), in turn majority-owned by private banks, in resolution process in the form of a Principal-Agent basis.

How will the bad bank work?

• NARCL and IDRCL will have an exclusive arrangement that will be

- as per the scope defined in the 'Debt Management Agreement' to be executed between these two entities.
- This arrangement will be on a 'Principal-Agent' basis and final approvals and ownership for the resolution shall lie with NARCL as the Principal.

REVERSE REPO NORMALISATION

In a recent report, State Bank of India, which is the largest public sector bank in the country, has stated: "...we believe the stage is set for a reverse repo normalisation."

Background

- The reverse repo is the interest rate that the RBI pays to the commercial banks when they park their excess "liquidity" (money) with the RBI. The reverse repo, thus, is the exact opposite of the repo rate.
- Under normal circumstances, that is when the economy is growing at a healthy pace, the repo rate becomes the benchmark interest rate in the economy.
- But imagine a scenario where the RBI pumps more and more liquidity into the market but there are no takers of fresh loans.
- In such a scenario, Banks are more interested in parking their excess liquidity with the RBI. And that is how the reverse repo becomes the actual benchmark interest rate in the economy.

What does reverse repo normalisation mean?

- Simply put, it means the reverse reporates will go up.
- Over the past few months, in the face of rising inflation, several central banks across the world have either increased interest rates or signaled that they would do so soon.

 In India, too, it is expected that the RBI will raise the repo rate. But before that, it is expected that the RBI will raise the reverse repo rate and reduce the gap between the two rates.

ECONOMIC SURVEY 2022: KEY HIGHLIGHTS OF ECONOMIC SURVEY

- Finance Minister, Nirmala Sitharaman has presented Economic Survey 2021-22 in the Parliament on 31st January 2022.

The pre-budget Economic Survey, which is tabled in Parliament ahead of the Union Budget to present the state of the economy and suggest policy prescriptions. The pre-Budget Economic Survey is authored by a team led by Chief Economic Advisor (CEA). Days before the presentation, the Centre appointed economist V Anantha Nageswaran as the new CEA.

What is the Economic Survey?

- Economic Survey is an annual document of the Ministry of Finance. It reviews the economic progress of the country and issues in the last 12 months.
- The survey provides information related to the performance of key developmental schemes launched by the government. The document also explains the performance of major government policies and their impact.
- The Economic Survey discusses major fiscal developments, macroeconomic factors, inflation, and other economic factors. The document also highlights the impact of agriculture, climate change, and employment on the economy of the country.

• The 1st Economic Survey was tabled in 1950-51. However, till the year 1964, it was presented along with the budget.

State of the Economy

- Indian economy is estimated to grow by 9.2 per cent in real terms in 2021-22 (as per first advanced estimates) subsequent to a contraction of 7.3 per cent in 2020-21.
- GDP is projected to grow by 8- 8.5 per cent in real terms in 2022-23.


About

- The SVP 2021-22 is open to all categories of schools. i.e. Government, Government aided and Private schools in both rural and urban areas.

Criteria

 The schools will be assessed through an online portal & mobile app in 6 subcategories. These are: Water, Sanitation, Hand Washing with soap, Operation and Maintenance, Behaviour Change and Capacity Building and the newly added category on COVID-19 Preparedness and Response and the system will generate the overall score and rating automatically.

Awards

- Schools shall be awarded at the District, State and National level based on an internationally recognized five star rating system.
- Also, every school will get a certificate of participation showing the category-wise scores and overall rating of the school.
- At the National level, 40 schools will be selected for awards this year under overall category.
- The award money for the schools has been enhanced this year from Rs. 50,000/- to Rs. 60,000/- per school, under Samagra Shiksha scheme. Also, 6 sub-category wise awards have been introduced for the first time, with award money of Rs. 20,000/- per school.

STREETS FOR PEOPLE CHALLENGE; NURTURING NEIGHBOURHOODS CHALLENGE

OMISURE

The Indian Council of Medical Research (ICMR) has approved a testing kit for detecting the Omicron variant of SARS-CoV-2.

About

- The kit is manufactured by Tata Medical and Diagnostics and is named OmiSure.
- The kit will be used to confirm Omicron in patients with its S-Gene Target Failure (SGTF) strategy.
- The kit currently in use to detect Omicron in India has been developed by the U.S.based scientific instrumentation company Thermo Fisher. It, too, uses the SGTF strategy to detect the variant.

IHU' VARIANT OF COVID-19

Even as the Omicron variant of the coronavirus continues to infect people in large numbers across the world, news about the emergence of another highly-mutated variant spread rapidly on January 4, 2022, raising fears of yet another wave of infections

About

- This variant, B.1.640, has been found mostly in France so far, although it has also been detected in several other countries. The variant was reported to have 46 mutations, including some in the spike protein.
- The B.1.640 variant is not new. It has been around for at least three months.

- The sudden discussion around it was triggered by the circulation of a week-old study by researchers from Méditerranée Infection in Marseille, part of France's Instituts hospitalo-universitaires (IHU, or University Hospital Institutes).
- The study reports the detection of a new variant in November last year among 12 people living in the same geographical area of southeastern France, the first of which had returned from a trip to Cameroon.
- The IHU variant that the researchers mention is B.1.640 which, according to global databases, was first discovered way back in January last year. The one that the French researchers found among people in November has now been classified as a sub-lineage B.1.640.2.
- While the large number of significant mutations in this variant has attracted the interest of researchers, and raised concerns among the public, the B.1.640 is not spreading at a rate that is unnerving. It is certainly not as alarming as the spread of Omicron.

SYNAPSES

 Neurons, or nerve cells, in the brain connect by means of junctions known as synapses through which they transmit signals. Recent work by researchers at the National Centre of Biological Sciences, Bengaluru, has thrown light on what stimulates these synapses to form

Types of synapses

- There are two types of synapses chemical and electrical.
- In chemical synapses, there is a space of about 20 nanometres between two neurons, and the way they communicate is this: One neuron converts electrical signal into chemical signals and this chemical is released into the synaptic space and the receiving neuron converts the chemical signal back into an electrical signal.
- As far as the electrical synapse goes, this is not the way it operates. In these synapses, the two neurons have a physical connection and the conversion of electrical to chemical need not occur, and they communicate directly.
- Electrical synapses are like a physical wire, communication is faster but they are also fewer in number.

Zebrafish

- Researchers from TIFR-National Centre of Biological Sciences, Bengaluru, have chosen Zebrafish as a model organism to study this process.
- Zebrafish are transparent and neuron development in larval zebrafish can be observed from day to day by injecting a dye or by engineering the fish to express fluorescent proteins.

LIQUID MEDICAL OXYGEN (LMO)

Indian Railway has transported more than 14 thousand tons of Medical Liquid Oxygen, LMO to the Hospitals and Covid care centers in the state of Punjab, Haryana, Uttar Pradesh, Uttrakhand and Delhi through its 8 hundred 58 Special freight trains run by Northern Railway.

About

- Oxygen is crucial for the treatment of patients with severe COVID-19, since the disease affects lung functioning.
- One of the ways in which this oxygen can be supplied is through Liquid Medical Oxygen (LMO). LMO is nothing but high purity oxygen used for medical treatment, and is developed for use in the human body.
- Why in liquid state? Due to its low melting and boiling points, oxygen is in a gaseous state at room temperature. Liquification enables storage in larger volume and easier transportation.

How Liquid Medical Oxygen is produced?

- There are several methods. The most common production method is separation of oxygen in what are known as Air Separation Units or ASUs.
- ASUs are basically plants that separate large volumes of gases. They use a method called Fractional Distillation Method to produce pure oxygen from atmospheric air, which consists mostly of nitrogen and oxygen 78% nitrogen, 21% oxygen and remaining 1% other gases including argon, carbon dioxide, neon, helium, and hydrogen.
- In this method, gases from the air are separated into various components after cooling them into a liquid state and then liquid oxygen is extracted from it.
- Atmospheric air is first cooled to -181°C.
 Oxygen liquifies at this point. Since, the boiling point of Nitrogen is -196°C, it remains in a gaseous state. But Argon has a boiling point similar to that of oxygen (-186°C) and hence a significant amount of Argon liquifies along with Oxygen.

- The resultant mixture of Oxygen and Argon is drained, decompressed and passed through a second low-pressure distillation vessel for further purification.
- We then get the output as final purified liquid oxygen, which is then transported using cryogenic containers

BARICITINIB; **SOTROVIMAB**

The World Health Organization (WH0) has recommended two drugs, baricitinib and sotrovimab, for treatment of Covid-19.

Baricitinib

- Baricitinib, which is also used to treat rheumatoid arthritis, has been "strongly recommended" for patients with severe or critical Covid-19 in combination with corticosteroids.
- It is part of a class of drugs called Janus kinase (JAK) inhibitors that suppress the overstimulation of the immune system.
- It is an oral drug, and provides an alternative to other arthritis drugs called Interleukin-6 receptor blockers, recommended by WHO in July 2021.

Sotrovimab

- Sotrovimab, developed by GlaxoSmithKline with US partner Vir Biotechnology Inc, is an investigational monoclonal antibody for use in treating conditions caused by coronavirus.
- The WHO has conditionally recommended its use for treating mild or moderate Covid-19 in patients who are at high risk of hospitalization.
- These include patients who are older, are immunocompromised, and have underlying conditions like diabetes, hypertension and obesity, and are unvaccinated

• The US Food and Drug Administration (FDA) too has approved an emergency use authorization (EUA) for the therapy for the treatment of mild to moderate Covid-19 in patients above 12 years.

CDRI DEVELOPS OMICRON TESTING KIT NAMED "OM"

- CSIR-Central Drug Research Institute (CDRI) has developed an indigenous RT-PCR diagnostic kit, 'Om', for the testing of the Omicron variant of coronavirus.
- It is the first kit made by any government institution, and the third to be made indigenously, for specific testing of Omicron.

About "Om"

- Om enables quick and cost-effective detection of omicron variants over genome sequencing for a large population. It was made within two months and will cost around Rs 150.

ORAL CANCER

Scientists from IIT Kharagpur have developed a portable, user-friendly, and noninvasive device for detecting oral cancer in resource-constrained clinical settings.

About

- Experts from the Guru Nanak Institute
 of Dental Sciences and Research in West
 Bengal supervised the clinical trials,
 and have established the efficacy of the
 new method in differentiating cancerous
 and precancerous stages of suspected
 oral abnormalities, as verified by highstandard biopsy reports.
- The research has been published recently in the prestigious Proceedings of the National Academy of Sciences (PNAS), USA.
- This is a low-cost, handheld imaging device to screen oral cancer and precancer based on measured change in blood flow rate of the tissue from thermal imaging and analytics.
- The handheld unit combines various sensors and controllers that feed the measured data to a computer simulation engine to classify normal, precancer and cancer cases in the oral cavity without needing referral to specialised medical

centres for resource-intensive diagnostic procedures.

Oral cancer

- Cancer of the oral cavity remains one of the major causes of morbidity and mortality in socially-challenged and underserved communities.
- There is an 80 per cent chance on average of a five-year survival rate if diagnosed early; the survival rate drops to 65 per cent or less in more advanced stages of the disease.
- In reality, most oral cancers remain undetected until they have reached an advanced stage.

ULTRA-LONG PERIOD MAGNETAR

Scientists have detected what appears to be an incredibly dense star behaving unlike anything else ever seen - and suspect it might be a type of exotic astrophysical object whose existence has been only hypothesised until now.

- The object, spotted using the Murchison Widefield Array telescope in outback Western Australia, unleashed huge bursts of energy roughly three times per hour when viewed from Earth during two months in 2018.
- It may be the first known example of what is called an "ultra-long period magnetar."
- This is a variety of neutron star the compact collapsed core of a massive star that exploded as a supernova - that is highly magnetised and rotates relatively slowly, as opposed to fast-spinning neutron star objects called pulsars that appear from Earth to be blinking on and off within milliseconds or seconds.

- It is located relatively close to Earth in cosmic terms, roughly 4,200 light years away, where a light year is the distance light travels in a year, 9.5 trillion km.
- Neutron stars including pulsars are among the universe's densest objects.
- They are roughly 12 km in diameter akin to the size of a city but with more mass than our Sun.
- A neutron star with an extreme magnetic field, a magnetar, could potentially power the radio pulsations, the researchers said.

INTRANASAL VACCINES

The Drugs Controller General of India Friday approved the trials of intranasal booster doses against Covid-19 that is being manufactured by Bharat Biotech, the maker of Covaxin.



About

- Vaccines are usually given through different routes, with the most common being injectable shots delivered into the muscles (intramuscular) or the tissue just between the skin and the muscles (subcutaneous).
- Other routes of delivery, especially in some vaccines for infants, include administering the liquid solution orally instead of injecting. In the intranasal route, the vaccine is sprayed into the nostrils and inhaled.

The importance of such vaccines

- Many viruses, including the coronavirus, enter the body through mucosa wet, squishy tissues that line the nose, mouth, lungs and digestive tract triggering a unique immune response from cells and molecules there. Intramuscular vaccines generally fail at eliciting this mucosal response, and instead rely on immune cells mobilised from elsewhere in the body flocking to the site of infection.
- Experts believe an intranasal vaccine will act against the virus from the time it tries to break the body's barrier, thereby making it more effective than the intramuscular ones in many cases.
- Experts believe an intranasal vaccine will act against the virus from the time it tries to break the body's barrier, thereby making it more effective than the intramuscular ones in many cases.
- These vaccines aim to overcome potential difficulties with mass vaccination and reduce the cost by doing away with the need for needles and syringes. Intranasal vaccines are also expected to cut down on the dependence on various trained personnel to administer the vaccine.

BA.2 SUB-VARIANT OF OMICRON

In the last couple of weeks, there has been a noticeable increase in the discovery of BA.2 sub-variant of Omicron from several countries, leading to fresh worries about the possibility of another surge in cases.

- Last week, the UK Health Security Agency flagged this sub-variant and designated it as a 'variant under investigation'.
- This sub-variant has been present in substantial numbers in India as well, but

India is not amongst the countries where the recent increase has been noticed.

A sub-variant of Omicron

- 2 is one of the several sub-variants of the Omicron which has spread rapidly across the world since November.
- The Omicron name was given to the B.1.1.529 lineage after it was designated as a variant of concern.
- Later, it was found that this lineage had small variations of its own, and the three most common were named B.1.1.529.1, B.1.1.529.2, and B.1.1.529.3. For ease of reference, however, these sub-lineages were later re-classified as BA.1, BA.2 and BA.3.
- The Omicron sub-variant that has been most common in circulation till now is BA.1. This continues to be the case even now, though the proportion of BA.2 is on the rise.

SMALL SATELLITE LAUNCH VEHICLE (SSLV)

The new chairman of the Indian Space Research Organisation Dr S Somanath indicated at a meeting with the minister of state for space Jitendra Singh Tuesday that ISRO's indigenous new launch rockets, called the Small Satellite Launch Vehicle (SSLV), will have its much-delayed, maiden development flight this April.

- The ISRO chairman has mentioned the launch of an "SSLV-D1 Micro SAT in April 2022."
- The SSLV is intended to cater to a market for the launch of small satellites into low earth orbits which has emerged in recent years on account of the need for developing countries, private

- corporations, and universities for small satellites.
- The launch of small satellites has until now been dependent on 'piggy-back' rides with big satellite launches on ISRO's work-horse – the Polar Satellite Launch Vehicle which has had over 50 successful launches so far.
- The launch of small satellites as a consequence has been dependent on the finalising of launch contracts for the larger satellites by ISRO.
- The SSLV can carry satellites weighing up to 500 kg to a low earth orbit while the tried and tested PSLV can launch satellites weighing in the range of 1000 kg.
- The SSLV is the smallest vehicle at 110-ton mass at ISRO. It will take only 72 hours to integrate, unlike the 70 days taken now for a launch vehicle.
- Only six people will be required to do the job, instead of 60 people. The entire job will be done in a very short time and the cost will be only around Rs 30 crore. It will be an on-demand vehicle.



CHILIKA LAKE

Chilika Lake, the largest brackish water lake and wintering ground of birds in the Indian subcontinent, saw a million birds, including the uncommon Mongolian gull, visiting the waterbody this year.



About

- As per the Water Bird Status Survey-2022 conducted in the Chilika, 10,74,173 water birds (107 species) and 37,953 individuals (76 wetland dependent species) were counted in the entire lagoon.
- Last year, the count in the Chilika was over 12 lakh. Members who were part of the census also reported sighting the Mongolian gull.
- The census was undertaken jointly by the Odisha State Wildlife Organisation, the Chilika Development Authority (CDA) and the Bombay Natural History Society.
- The increase in numbers for the greater flamingo at Nalabana mudflat indicates that the restoration at Nalabana is effective. This year's greater flamingo count was the highest in the last decade. It

is largely due to appropriate management of mudflats.

Chilika Lake

- Chilika Lake is a brackish water lagoon, spread over the Puri, Khurda and Ganjam districts of Odisha state on the east coast of India, at the mouth of the Daya River, flowing into the Bay of Bengal, covering an area of over 1,100 km2.
- It is the biggest lake of India. It is largest salt water lake in India.
- Chilika Lake hosts birds migrating from thousands of miles away from the Caspian Sea, Lake Baikal, Aral Sea, remote parts of Russia, Mongolia, Central and Southeast Asia, Ladakh and the Himalayas.
- FIMBRISTYLIS SUNILII; NEANOTIS PRABHUII
- Researchers from SNM College Maliankara, the M.S. Swaminathan Research Foundation, and the Payyanur College have reported two new plant species from the biodiversity-rich Western Ghats regions in Thiruvananthapuram and Wayanad districts of Kerala. They have been christened Fimbristylis sunilii and Neanotis prabhuii.

Fimbristylis sunilii



- Collected from the grasslands of Ponmudi hills, Thiruvananthapuram, Fimbristylis sunilii has been named after plant taxonomist C.N. Sunil, retired professor and research guide of Botany, SNM College.
- A perennial plant of the Cyperaceae family, it stands 20-59 cm tall and was collected from an elevation of 1,100 metres.
- Fimbristylis sunilii has been provisionally assessed as data deficient (DD) under the IUCN Red List categories.

Neanotis prabhuii

- Neanotis prabhuii is a prostrate perennial herb named after K.M. Prabhukumar, Senior Scientist at CSIR-NBRI, Lucknow, in recognition of his research on flowering plants of the Western Ghats.
- Discovered in the Chembra Peak grasslands of Wayanad, it hails from the family Rubiaceae and grows on highaltitude grasslands.
- Neanotis prabhuii grows up to 70 cm in length and is many-flowered with the petals pale pink in colour.

GANODERMA

Researchers from Kerala have identified two new species of fungi from the genus Ganoderma that are associated with coconut stem rot.




About

- They have also genotyped the two fungi species, named Ganoderma keralense and G. pseudoapplanatum and identified genetic biomarkers.
- The DNA barcodes have been made publicly available in DNA sequence repositories so that future studies can use it for early detection of the pathogen. The research was published in the journal Mycologia.
- The butt rot or basal stem rot of coconut is known by several names in different parts of India: Ganoderma wilt (Andhra Pradesh), Anaberoga (Karnataka) and Thanjavur wilt (Tamil Nadu), to mention a few.
- The infection begins at the roots, but symptoms include discolouration and rotting of stem and leaves. In the later stages, flowering and nut set decreases and finally the coconut palm (Cocos nucifera) dies.

KERALA BIRD ATLAS (KBA)

The Kerala Bird Atlas (KBA), the first-of-its-kind State-level bird atlas in India, has created solid baseline data about the distribution and abundance of bird species across all major habitats, giving an impetus to futuristic studies.



About

- Conducted as a citizen science-driven exercise with the participation of over 1,000 volunteers of the birdwatching community, the KBA has been prepared based on systematic surveys held twice over 60 days a year during the wet (July to September) and dry (January to March) seasons between 2015 and 2020.
- The KBA accounts for nearly three lakh records of 361 species, including 94 very rare species, 103 rare species, 110 common species, 44 very common species, and 10 most abundant species.
- It is arguably Asia's largest bird atlas in terms of geographical extent, sampling effort and species coverage derived from the aggregation of 25,000 checklists.
- It was found that the species count was higher during the dry season than in the wet season while species richness and evenness were higher in the northern and central districts than in the southern districts.
- Most of the endemics were concentrated in the Western Ghats while the threatened species were mostly along the coast.
- The survey ignored the short duration passage of migrant species.

STATE ENVIRONMENTAL IMPACT ASSESSMENT AGENCIES (SEIAA)

A proposal by the Union Environment Ministry to "rank" and "incentivise" States on how quickly they could give environmental clearances to proposed infrastructure projects has drawn fire from environmentalists on the grounds that it contravenes basic principles of environmental regulation.

About

- A note to States by the Union Environment Ministry on January 17 spells out seven criteria to rate State Environmental Impact Assessment Agencies (SEIAA) on "transparency, efficiency and accountability".
- On a scale of seven, a SEIAA, for instance, gets two marks for granting a clearance in less than 80 days, one mark for within 105 days and no marks for more.
- If less than 10% of the projects for scrutiny prompted a site visit by committee members, to examine ground conditions, a SEIAA would get one mark.
- More than 20%, on the other hand, would be a demerit or zero marks. SEIAA with a score of seven or more would be rated 'five star.'
- Ministry officials said that the ranking criteria was not intended to accelerate the speed with which clearances were accorded but to encourage the SEIAA to take quicker decisions on approving or rejecting a project, and adhere to timelines already specified by the provisions of the Act.
- The project appraisal process is an online process where aspirant companies must upload documents on a portal called Parivesh.

TIGER ESTIMATION

Tiger census will commence at Bandipur and at Nagarahole as part of the All-India Tiger and Mega Herbivore Estimation.

About

• This is part of the nation-wide enumeration that is held once in four

- years and is the fifth such exercise being taken up the earlier ones being held in 2006, 2010, 2014, 2018.
- In the 2018 census, there were 125 tigers in Nagarahole whereas there were 72 tigers in the 2014 exercise which was a big jump.
- Nagarahole Tiger Reserve is located in Kodagu district and Mysore district in Karnataka.
- Bandipur National Park is located in Chamarajnagar district in It was established as a tiger reserve under Project Tiger in 1973. It is part of the Nilgiri Biosphere Reserve since 1986.

MSTRIPES

- This year's enumeration exercise entails the use of MSTRIPES (Monitoring System for Tigers Intensive Protection and Ecological Status) app and apart from the tiger counts, the exercise will also throw up data on mega herbivores, including elephants and gaurs.
- The use of apps ensures that the data is not only digitised but is uploaded on a real-time basis and is robust.

RAMGARH WILDLIFE SANCTUARY SET TO BE NOTIFIED AS 4TH TIGER RESERVE OF RAJASTHAN

- Ramgarh Vishdhari Wildlife Sanctuary, which is among the proposed five sites in the country, is expected to be formally notified as tiger reserve (TR) soon before the Global Tiger Summit, which is to be held at Vladivostok, Russia.
- The Centre has already given its approval of granting tiger reserve status to Ramgarh Vishdhari Wildlife Sanctuary, along with MM Hills in Karnataka, Guru Ghasidas National Park in Chhattisgarh.

About the Ramgarh Vishdhari Sanctuary

- The Ramgarh Vishdhari Sanctuary will be spread across 1,071 sq kms. A 302 Sq Km area in the proposed tiger sanctuary will be left as critical habitat for Tigers and the rest of the area will act as a buffer zone for the Ranthambore National Park.
- Ramgarh Vishdhari Wildlife Sanctuary was established in 1982.
- The core areas of the sanctuary have 8 villages and are home to large numbers of wild animals like sambhars, caracals, wild boars, nilgai, and striped Hyena.

SEPTEMERANTHUS

A new genus of a parasitic flowering plant has recently been discovered from the Nicobar group of islands.



- The genus Septemeranthus grows on the plant species Horsfieldia glabra (Blume) Warb.
- The parasitic flowering plants have a modified root structure spread on the stem of the tree and are anchored inside the bark of the host tree.
- The plant was found on the periphery of the tropical forest in one of the biodiversity hotspots referred to as the Nicobar group of islands separated from the Andaman group of Islands by a wide gap of 160 km with heavy tidal flows.

- The genus Septemeranthus has a distinct vegetative morphology, inflorescence architecture and floral characters.
- The leaves of the plant are heart-shaped with a very long tip and the ovary, fruit and seeds are 'urceolate' (earthen potshaped). The flowers have five persistent bracts having conspicuous margins.
- The name Septemeranthus is derived from the Latin word 'septem' meaning 'seven', referring to the arrangement of flowers. The genus belongs to the family Loranthaceae, a hemi-parasite under the sandalwood order Santalales and is of widespread importance.

WORLD ECONOMIC PROSPECTS REPORT

WORLD BANK PROJECTS INDIA'S GDP GROWTH AT 8.3% IN FY22

- The World Bank has projected the Indian economy to grow at the following rate in its 'Global Economic Prospects' report released on January 11, 2022.
- The World Bank retained its FY22 growth forecast for India at 8.3 per cent but upgraded it to 8.7 per cent for FY23, from 7.5 per cent estimated earlier, citing improving growth prospects, especially a reviving private capex cycle.
- The Bangladesh GDP will grow at 6.4 percent in the FY 2021-22 ending June 2022, due to increasing services activity and firming exports of readymade garment, says the World Bank.
- GDP growth rate is forecast to go up to 6.9 percent in 2022-23. Bangladesh economy is estimated to have grown at 5 percent in the current fiscal 2020-21 up from 3.5 percent in 2019-20.
- In its latest Global Economic Prospects report announced on Wednesday, the WB noted that growth prospects in South Asia have improved since June 2021 because of improved prospects in India, Bangladesh and Pakistan.
- Regional growth is expected to accelerate to 7.6 percent in 2022 as pandemic related disruptions fade. However, it will decelerate to 6.0 percent in 2023. Despite the upward revision to growth, output

- in 2023 is still projected to be almost 8 percent lower than projected before the pandemic.
- The World Bank noted that the emergence of the Omicron variant could hinder economic activity by requiring additional restrictions on mobility. It says that climate risks are becoming more prevalent in South Asia as cyclones, floods, and droughts have become more frequent.
- The region is one of the most vulnerable to climate-induced increases in poverty, disease, child mortality and food price, says the World Bank.

HENLEY PASSPORT INDEX 2022

- India has improved its position by seven places to rank at 83rd place among 111 countries in the latest Henley Passport Index, released for Q1 of 2022. India ranked at 90th spot among 116 countries in Q4 of 2021 in October.
- Oman and Armenia are the latest destinations where Indian passport holders can visit without obtaining a visa.

On a global level

 Japan and Singapore have retained the joint top position in the Henley Global Mobility Report 2022 Q1. Their passports holders are allowed to travel visa-free to 192 countries. Afghanistan has the world's least powerful passports, with a visa-free score of 26.

INDIA FOREST SURVEY REPORT 2021

• The Minister for Environment, Forest and Climate Change released the 'India State of Forest Report 2021' prepared by the Forest Survey of India (FSI) which has been mandated to assess the forest and tree resources of the country.

Major Findings

- The total forest and tree cover of the country is 80.9 million hectares which is 24.62 percent of the geographical area of the country.
- As compared to the assessment of 2019, there is an increase of 2,261 sq km in the total forest and tree cover of the country. Out of this, the increase in the forest cover has been observed as 1,540 sq km and that in tree cover is 721 sq km.
- Increase in forest cover has been observed in open forest followed by very dense forest. Top three states showing increase in forest cover are Andhra Pradesh (647 sq km) followed by Telangana (632 sq km) and Odisha (537 sq km).
- Area-wise Madhya Pradesh has the largest forest cover in the country followed by Arunachal Pradesh, Chhattisgarh, Odisha and Maharashtra.
- In terms of forest cover as percentage of total geographical area, the top five States are Mizoram (84.53%), Arunachal Pradesh (79.33%), Meghalaya (76.00%), Manipur (74.34%) and Nagaland (73.90%).
- 17 states/UT's have above 33 percent of the geographical area under forest cover.
 Out of these states and UT's, five states/ UTs namely Lakshadweep, Mizoram, Andaman & Nicobar Islands, Arunachal Pradesh and Meghalaya have more than 75 percent forest cover.

- Total mangrove cover in the country is 4,992 sq km. An increase of 17 sq Km in mangrove cover has been observed as compared to the previous assessment of 2019. Top three states showing mangrove cover increase are Odisha (8 sq km) followed by Maharashtra (4 sq km) and Karnataka (3 sq km).
- Total carbon stock in country's forest is estimated to be 7,204 million tonnes and there an increase of 79.4 million tonnes in the carbon stock of country as compared to the last assessment of 2019. The annual increase in the carbon stock is 39.7 million tonnes.

DIGITAL PAYMENT INDEX

• The RBI's Digital Payment Index, which shows the deepening of payments through digital modes in India, rose by 39.64 per cent to 304.06 in September 2021 against 217.74 in the year-ago month.

UNCTAD REPORT: FDI FLOWS TO INDIA FALLS BY 26% IN 2021

- Foreign Direct Investment (FDI) flows to India fell by 26 per cent in 2021, compared to 2020, as per the UN Conference on Trade and Development (UNCTAD) Investment Trends Monitor published.
- UNCTAD said that low FDI in India was mainly because large cross-border mergers & acquisitions (M&A) deals recorded in 2020 were not repeated.
- The global FDI flows increased by 77 per cent to an estimated USD 1.65 trillion in 2021, from USD 929 billion in 2020.
- CORRUPTION PERCEPTIONS INDEX (CPI) 2021: INDIA RANKS 85TH
- Transparency International has released the Corruption Perceptions Index (CPI) 2021 in which India has been ranked at 85th spot (Score of 40).

- The ranking has been topped jointly by three countries- Denmark, Finland and New Zealand (Score of 88).
- This ranking measures how corrupt each country's public sector is perceived to be.
- The results are given on a scale of 0 (highly corrupt) to 100 (very clean). 180 countries are ranked in it.
- Last year (for 2020) India was ranked 86th with a score of 40.
- This year's Corruption Perceptions Index (CPI) reveals that corruption levels are at a worldwide standstill.
- The global average remains unchanged for the tenth year in a row, at just 43 out of 100 points.

- Kohli holds the record for most Test appearances as India Test captain (68) and he also holds the record for most Test wins by an Indian captain (40). Only Graeme Smith, Ricky Ponting, and Steve Waugh have won more matches than Kohli as captain in Test cricket.

- Under his dynamic captaincy India became a formidable force and dominated every team at home. He became the firstever Asian captain to win a Test series in Australia.
- Under him, the team reclaimed the top spot in the ICC test rankings, and also qualified for the final of the first ever ICC World Test Championship.
- Kohli also holds the record for scoring most Test centuries (20) as India captain.

About

- Sapkal, who had received the Padma Shri last year, had completed 74 years in November.
- Born on November 14, 1948, in Wardha district of Maharashtra, Sapkal was forced to drop out of school after she had passed Class IV.
- Sapkal, who grew up in extreme poverty, went on to set up institutes for orphan children.
- Having raised over 1,050 orphan children, she could boast of having 207 sons-inlaw and 36 daughters-in-law.

FATIMA SHEIKH

• On 9 January 2022, Google honoured Fatima Sheikh with a doodle on her 191st birth anniversary.

About

- Fatima Sheikh was an Indian educator, who was a colleague of the social reformers Jyotiba Phule and Savitribai Phule.
- Fatima Sheikh was the sister of Mian Usman Sheikh, in whose house Jyotiba and Savitribai Phule took up residence.
- One of the first Muslim women teachers of modern India, she started educating Dalit children in Phules' school.

- Jyotiba and Savitribai Phule along with Fatima Sheikh took charge of spreading education among the downtrodden communities.
- Sheikh met Savitribai Phule while both were enrolled at a teacher training institution run by Cynthia Farrar, an American missionary.



 She taught at all five schools that the Phules went on to establish and she taught children of all religions and castes.
 Sheikh took part in the founding of two schools in Bombay in 1851.

LAL BAHADUR SHASTRI

Lal Bahadur Shastri was India's second Prime Minister, who breathed his last at the age of 61 on January 11, 1966. His famous slogan "Jai Jawan Jai Kisan" captures the spirit of India and inspires all generations. He promoted the White Revolution and Green Revolution in India, which led to an increase in the production of milk supply and food grain, respectively.

Key facts about him

 Lal Bahadur Shastri was only 16 when Mahatma Gandhi called upon the countrymen to join the Non-Cooperation Movement. Lal Bahadur Shastri at once responded to Mahatma Gandhi's call. He was deeply influenced by Mahatma Gandhi.

- He was minister in the Union Cabinet from 1951 to 1956 when he resigned taking responsibility for the railway accident and later from 1957-1964.
- Lal Bahadur Shastri's slogan 'Jai Jawan, Jai Kisan' during the 1965 war boosted the morale of the soldiers as well as farmers amid food scarcity.
- Lal Bahadur Shastri promoted the White Revolution, a countrywide campaign to increase milk production. He supported the Amul milk co-operative at Anand in Gujarat and created the National Dairy Development Board.
- To boost India's food production, Lal Bahadur Shastri promoted the Green Revolution in India in 1965, which led to an increase in food grain production, especially in Punjab, Haryana and Uttar Pradesh.
- He signed an agreement with then Ceylon (now Sri Lanka) on persons of Indian origin there, in 1964 — an endorsement of the importance of the neighborhood.

Death

 Shastri's Prime Ministership came to an abrupt end on 10th January 1966, when he suddenly expired in Tashkent, then in the USSR and currently the capital of Uzbekistan. He was there to discuss and sign an agreement (Tashkent Agreement).

Legacy

• He was the first person to be posthumously awarded the Bharat Ratna (1966).

NARAYAN DEBNATH

 Legendary Bengali comics artist, writer and illustrator, Narayan Debnath, has passed away after a prolonged illness.

- The celebrated cartoonist was the creator of popular Bengali comic strips like Handa Bhonda (1962), Bantul the Great (1965) and Nonte Phonte (1969).
- In 2021, Debnath was awarded Padma Shri, the fourth highest civilian award in India

POET MAYA ANGELOU

- The US Treasury has minted coins featuring poet Maya Angelou the first black woman ever featured on the US 25-cent coin known as a quarter. Angelou, a poet and activist, was the first black woman to write and perform a poem at a presidential inauguration.
- In 2010, she was given a Presidential Medal of Freedom, the highest US civilian award by President Barack Obama.

M. K. PRASAD

- Noted environmentalist & 'Save Silent Valley' campaigner M.K. Prasad passes away.
- He was a prominent figure in the historic grassroots level movement to save the evergreen tropical rain forests in Kerala's Silent Valley from destruction.
- He had also led the popular science movement, 'Kerala Sasthra Sahithya Parishath'

JAHNAVI DANGETI

- Jahnavi Dangeti, a young girl from Andhra Pradesh, has just completed NASA's International Air and Space Program (IASP) at the Kennedy Space Centre in Alabama, US.
- She is a member of the International Organization of Aspiring Astronauts (IOAA)

NETAJI SUBHAS CHANDRA BOSE

• In order to commemorate the 125th birth anniversary of the great freedom fighter Netaji Subhas Chandra Bose and as part of the year-long celebrations, the government has decided to install a grand statue of Netaji Subhas Chandra Bose at India Gate.

About



- The statue, made of granite, shall be a fitting tribute to the immense contribution of Netaji in our freedom struggle, and would be a symbol of the country's indebtedness to him.
- Till the work for the statue is completed, a hologram statue of Netaji will be present at the same place. Prime Minister Shri Narendra Modi will unveil the hologram statue of Netaji at India Gate on 23rd January, 2022.
- The hologram statue will be powered by a 30,000 lumens 4K projector.
- An invisible, high gain, 90% transparent holographic screen has been erected in such a way so that it is not visible to visitors. The 3D image of Netaji will be projected on it to create the effect of a hologram. The size of the hologram statue is 28 feet in height and 6 feet in width.

Subhas Chandra Bose Aapda Prabandhan Puraskars

- He was awarded India's third highest civilian award the Padma Bhushan in 2018.

AYESHA MALIK


 In a historic moment for Pakistan's judiciary, Lahore High Court's Justice Ayesha Malik was sworn in as the Supreme Court's first female judge

About

- India's first female judge Justice Fathima Beevi was appointed in 1989.

PANDIT BIRJU MAHARAJ

 The Prime Minister Narendra Modi has expressed deep grief over the passing away of legendary Kathak dancer Pandit Birju Maharaj.



About

- Pandit Birju Maharaj (1937 2022), better known simply as Birju Maharaj, was an Indian dancer, composer, singer and exponent of the Lucknow "Kalka-Bindadin" Gharana of Kathak dance in India
- He was a descendant of the Maharaj family of Kathak dancers, which includes his two uncles, Shambhu Maharaj and Lachhu Maharaj, and his father and guru, Acchan Maharaj.
- He also practised Hindustani classical music and was a vocalist.
- After working along with his uncle, Shambhu Maharaj at Bhartiya Kala Kendra, later the Kathak Kendra, New Delhi, he remained head of the latter, for several years, till his retirement in 1998 when he opened his own dance school, Kalashram, also in Delhi.

- INS Vikrant, also known as Indigenous Aircraft Carrier 1 (IAC-1), is an aircraft carrier constructed by the Cochin Shipyard Limited (CSL) for the Indian Navy.
- It is the first aircraft carrier to be built in
- It is named 'Vikrant' as a tribute to India's first aircraft carrier, Vikrant (R11).
- The name Vikrant (Sanskrit vikrānta, literally "stepping beyond") means "courageous".
- The motto of the ship is "Jayema Sam Yudhi Sprdhah", which is taken from Rigveda and means "I defeat those who fight against me".
- Vikrant is scheduled to be commissioned into service by August 2022, with flight trials of aircraft expected to be completed by mid-2023.

- The missile has miniaturised infrared imaging seeker and advanced avionics for on-board control and guidance. The missile performance has been proven for the maximum range in earlier test trials.

DEFENCE REFORMS

Defence Ministry launched three new initiatives for the welfare of ex-servicemen and their families on the occasion of Armed Forces Veterans Day.

About

PASSEX EXERCISE

About the exercises

• These exercises are aimed at enhancing interoperability, improving understanding and imbibing best practices between both the friendly navies, and this will involve advanced surface and anti-submarine warfare exercises, weapon firings, seamanship exercises and helicopter operations, Navy officials said, adding that these exercises are conducted regularly with units of friendly foreign navies, whilst visiting each other's ports or during a rendezvous at sea.

BRAHMOS

• In the first export order for the BrahMos supersonic cruise missile system, the Philippines has approved a \$374.96 mn contract for the purchase of shore-based anti-ship variant of the missile from India, while discussions are ongoing with a few other Southeast Asian counties.

 BrahMos supersonic cruise missile, with enhanced capability, successfully testfired off Odisha coast.

About

- BrahMos supersonic cruise missile, with increased indigenous content and improved performance, was successfully test-fired from Integrated Test Range, Chandipur off the coast of Odisha on January 20, 2022.
- The launch was conducted by Brahmos Aerospace in close coordination with the teams of Defence Research and Development Organisation (DRDO).
- The missile was equipped with advanced indigenous technologies and followed a modified optimal trajectory for enhanced efficiency and improved performance. The missile with the modified control system has been fine-tuned to achieve an enhanced capability.
- BrahMos Aerospace, the joint venture between DRDO and NPOM, Russia, has been continuously upgrading the powerful, highly versatile BrahMos to increase its effectiveness and lethality against sea and land targets. BrahMos is the potent missile weapon system already inducted into the Armed Forces.

'SEA TO SEA' VARIANT OF BRAHMOS MISSILE

 India successfully tested an advanced sea to sea variant of BrahMos Supersonic Cruise missile from INS Visakhapatnam.

About



- BrahMos, deployed by the Navy on its warships first in 2005, has the capability to hit sea-based targets beyond radar horizon.
- The naval variant was originally tested in October and December 2020 from the Navy's indigenously-built stealth destroyer INS Chennai and Rajput-class destroyer INS Ranvijay, respectively.
- This version of the missile has been designed to launch either in a vertical or a horizontal mode from moving/stationary assets to target both land and sea targets.
- The missiles, fired at a speed of 2.8 Mach or nearly three times the speed of sound, significantly increase the capability of the ships in engaging long-range targets.
- BrahMos missiles are designed and developed by BrahMos Aerospace, a joint venture company set up by Defence Research and Development Organisation (DRDO) and Mashinostroyenia of Russia.

INDIA & JAPAN CONDUCTED MARITIME PARTNERSHIP EXERCISE IN BAY OF BENGAL

- The Indian side was represented by Indian Naval Ships (INS) Shivalik and INS Kadmatt while JMSDF Ships Uraga and Hirado participated from the Japanese side.
- Strengthening bilateral relations, promoting defence cooperation, enhancing mutual understanding and interoperability, and sharing best practices between IN and JMSDF.

'SAAB'

 Swedish defence company 'Saab' had been selected by the Indian Armed Force through a competitive programme for the supply of single-shot anti-armour weapon AT4.

About the AT4

- AT4 will be operated by a single soldier and its single-shot system has proven efficacy against structures landing craft helicopters armoured vehicles and personnel. Its 84 mm calibre warhead offers enhanced power and performance to the Indian armed forces.
- The weapon can be fired with a range of projectiles, such as high-explosive anti-tank rounds, anti-structure tandem-warheads, and high explosive rounds. It can penetrate more than 17.5 inches (44 centimetres) of armour.
- The AT4 is equipped with an optical night sight for missions in low-light environments and has a minimum arming distance of 10 meters (32.8 feet), making it more accurate when hitting closer targets.

NATO PARTNERS TO HOLD MARITIME DRILLS IN MEDITERRANEAN SEA

• The name of the maritime exercise is "Neptune Strike '22". The naval drill will end on February 04, 2022. The main purpose of this exercise will be to demonstrate and test NATO's wide range of maritime capabilities.

INS KHUKRI

INS Khukri, lead ship of the Indian Navy's
Khukri class corvettes and an indigenous
surface-to-surface missile fitted vessel
that had the distinction of being part of
both, the Western and Eastern Fleets, is
scheduled to be handed over to the Diu
Administration

About

 Built by Mazagon Dock Shipbuilders, the ship was commissioned on 23 August 1989 in Mumbai.



- After more than 32 glorious years of service to the nation and having participated in all forms of naval operations, the ship was decommissioned in a solemn ceremony on 23 December 2021.
- The decommissioned vessel is the second ship of the Navy to carry the name INS Khukri, the first having been lost during the 1971 Indo-Pak War off the coast of Diu.
- As part of developing and revitalising the Khukri Memorial at Diu, the Diu Administration has plan to develop the ship as a full-scale museum.

S&T COOPERATION BETWEEN INDIAN AND FRANCE

• In an important milestone in S&T Cooperation between India and France an MoU was signed between CSIR and Institut Pasteur with a scope for cooperation in health research.

About

 In December, AIIB approved the \$150 million "Chennai City Partnership: Sustainable Urban Service Program"

- aiming to strengthen institutions and improve the quality and financial sustainability of selected urban services in Chennai.
- Also, the AIIB and the Asian Development Bank (ADB) in Manila are processing a \$2 billion loan request from India to purchase 667 million Covid-19 jabs.
- Pandian has consistently sought to dispel the notion that the AIIB is a Chinese bank, saying that except the US and Japan, most of the developed and developing countries have joined the bank.
- In late December, the AIIB approved the application of Iraq to join, becoming the bank's 51st regional member to bring its membership to 105.
- As of October 22, AIIB has overall approved 147 projects in 31 countries valued at \$28.97 billion.

About Netaji Subhash Chandra Bose

- Netaji' was born on January 23, 1897, in Cuttack in Odisha. He acquired a degree in philosophy and was later selected for the Indian Civil Services. He refused to join as he did not want to serve the British Government.
- Netaji joined the Indian National Congress in 1921.
- Netaji started a newspaper called "Swaraj".
- He had written a book called "The Indian Struggle". The book covers the Indian Independence movement between 1920 and 1942.
- The term "Jai Hind" was coined by Netaji Subhash Chandra Bose.

- With the slogan "Give me blood and I will give you freedom", he awakened the country towards fighting against the British.
- Netaji in the Indian independence struggle
- Netaji was prisoned in 1925 for his nationalist activities. Later released in 1927.
- After his release, he became the general secretary of the Indian National Congress.
 He formed the All India Forward Bloc as a part of the Indian National Congress in 1939.
- During the second world war, Netaji protested the British Raj for not consulting the Indians before pulling them into the war. He was arrested for his protests. Later he was released and was kept under surveillance.
- In 1941, Bose escaped to Germany via Afghanistan and the Soviet Union.
- In Germany, Netaji met German leaders and other Indian students and European political leaders.
- Netaji built a force known as the Azad Hind Fauj (Indian National Army) giving the slogan of "Dilli Chalo". Thousands of soldiers of his 60,000-strong army sacrificed their lives for the country. The Indian National Army supported the Japanese army in their invasion of Northeast India. They together took control of the Andaman and Nicobar Islands.

Structure of the Commission

 Originally the commission had only one election commissioner but after the Election Commissioner Amendment Act 1989, it has been made a multi-member body. The commission presently consists of one Chief Election Commissioner (CEC) and two Election Commissioners (ECs).

NATIONAL TOURISM DAY OF INDIA CELEBRATED ON 25 JANUARY

- India has moved up six places to 34th rank on the World travel and tourism competitiveness index of the World Economic Forum report 2019 since India has a rich culture of varied traditions, customs, and festivals which attracts the tourists.

INTERNATIONAL CUSTOMS DAY OBSERVED ON JANUARY 26

- The International Customs Day (ICD) is observed on 26 January every year.
- The day is celebrated to recognise the role of customs officials and agencies and focus on the working conditions and challenges that customs officers face in their jobs.
- This year, the theme chosen by WCO for ICD is 'Scaling up Customs Digital Transformation by Embracing a Data Culture and Building a Data Ecosystem'.

History of the day

• The day was instituted by the World Customs Organization (WCO) to commemorate the day in 1953 when the inaugural session of the Customs Cooperation Council (CCC) was held in Brussels, Belgium. In 1994 the CCC was renamed World Customs Organization (WCO).

INTERNATIONAL HOLOCAUST REMEMBRANCE DAY: 27 JANUARY

- International Day of Commemoration in memory of the victims of the Holocaust (International Holocaust Remembrance Day) is observed on 27 January.
- In 2022, the theme guiding the United Nations Holocaust remembrance and education is "Memory, Dignity and Justice".
- The objective of the day is to commemorate the anniversary of the tragedy of the Holocaust that occurred during the Second World War.

History of the day

- A genocide occurred during World War II in which Nazi Germany, aided by its collaborators, systematically murdered some six million European Jews, around two-thirds of the Jewish population of Europe, between 1941 and 1945.
- United Nations designated the day in 2005 to serve as a date for official commemoration of the victims of the Nazi regime and to promote Holocaust education throughout the world.

ANTI-LEPROSY DAY


• In India, Anti Leprosy Day is observed on 30th January every year.

 National Leprosy Eradication Programme is a centrally sponsored scheme. Its vision is "Leprosy-free India". Under this, action is taken for early case detection, complete treatment of detected cases and to contain the onset of disease in close contacts.



- Other initiatives under the programme include leprosy awareness campaigns and services for Disability Prevention and Medical Rehabilitation such as provision of Microcellular Rubber footwear, Aids & Appliances and self-care kits.
- Under the programme, Reconstructive Surgeries are conducted and welfare allowance is paid to each patient undergoing Reconstructive Surgeries.

KOCHI BECAME INDIA'S FIRST CITY TO HAVE A WATER METRO PROJECT

- Kochi, Kerala has become India's first city to have a Water Metro Project after the launch of its first boat in December 2021, namely 'Muziris,' among the 23 battery-powered electric boats being manufactured by Cochin Shipyard Limited.
- This launch is a part of the Rs 747-crore project which is operated by Kochi Water Metro Ltd (KWML). The boats will be called Water Metros.

DAVID BENNETT WORLD FIRST HUMAN RECEIVES A PIG HEART TRANSPLANT

• A US man has become the first person in the world to get a heart transplant from a genetically-modified pig.

- The possibility of using animal organs for so-called xenotransplantation to meet the demand has long been considered, and using pig heart valves is already common.
- Pigs are increasingly becoming popular candidates for organ transplantation. This is because their organs are anatomically similar to those of humans.

It was displayed at Longewala, along the India – Pakistan Border in Jaisalmer. Longewala was the centre stage of the historic battle of 1971 between India and Pakistan. It will be the fifth public display of the Khadi flag.

Dimension of the flag

• The Monumental National Flag is 225 feet long and 150 feet wide. It is approximately 1400 kgs in weight.

- 4500 meters of hand-woven, hand-spun, Khadi cotton bunting has been used to make the flag. It covers an area of 33, 750 square feet.
- The Ashok Chakra in the flag has a diameter of 30 feet.

PANDIT BIRJU MAHARAJ PASSES AWAY

 Legendary Kathak dancer, Pandit Birju Maharaj has passed away at the age of 83. A recipient of the country's second-highest civilian award, Padma Vibhushan, he was fondly called Pandit-ji or Maharaj-ji by his disciples and legions of followers and was one of India's bestknown artistes.

- The Ministry of Electronics and Information Technology (MeitY) has released a 5-year roadmap and Vision Document 2.0 for the electronics sector.
